The following orders were passed by the Board of Commissioners at their meeting on this day:

Ordered: That the Tax Collector refund Rex H. Wunderlick of Bolton Township on \$500.00 valuation for the year 1928, the reduction being granted on the ground of depreciation of some mill equipment. The Board of Commissioners voted the following way regarding the reduction: "Aye": D. F. Mc-Gougan, J. R. Blake, D. W. Merritt and H. G. Avant. "No": J. C. Hooks. Sr.

Ordered: That a refund be drawn authorizing the Tax Collector to cancel one tax receipt set up in the name of F. T. Richardson in Chadbourn Township for 1928, and that two tax receipts be set up by the Tax Supervisor in the name of F. T. Richardson to cover the listing. This alteration is made in order to get rid of a double listing made by Eli Smith and Brown Mercantile Company both of whom paid the tax in 1927, which amount (\$17.23) is hereby ordered refunded by voucher drawn in the name of Eli Smith and given to E. K. Proctor. This order is passed in order that two certain tracts of land covered by the one receipt may be set up separately on which both owners may pay their taxes individually.

Ordered: That two young mules be purchased from H. C. Hunt for use by the Chain Gang, the price of both to be \$400.00. Those voting "Aye" for the purchase of the mules were: J. R. Blake, D. W. Merritt, J. C. Hooks, Sr.; 1.900. voting "No" were: NI award

Ordered: That in consideration of a payment of \$200.00 on the note held by Columbus County against T. G. Sessions with interest on the full note to date, a release be granted by Columbus County on the timber over the lands covered by said mortgage.

Ordered: That the Sheriff summon the following good and lawful men to serve as Jurors during the Criminal Term of Superior Court which convenes January 28, 1929. Thirty-six men for the one week:
