The Honorable Board of County Commissioners met in the Commissioners' office of the Courthouse on Tuesday, May 7, 1929, according to adjournment. All members of the Board were present:

The purpose of this meeting was to transact any unfinished business carried over from the regular meeting of the Board on First Monday in May.

It was ordered by the Board of Commissioners: That two 56-inch ceiling fans and one 16-inch oscillating fan be installed over the Bar in the Courtroom; that bids from the various electrical contractors were to be obtained by H. G. Avant and the County Auditor, and that the installation of same was to be given to the lowest qualified bidder.

The matter of some adjustment on the expenditures made by the Chain Gang on the tractor bought of E. F. Craven Company was discussed by the Board with Mr. W. D. Underwood, representative of E. F. Craven Company. The Board of Commissioners voted to offer said company 50% of the total cost of a new track which was necessarily installed on said tractor on account of undue wearing of the original track. The representative of said company refused at this time to adjust the cost on a 50% cost basis. The matter, therefore, was deferred until Mr. Underwood had time to discuss the basis of adjustment as offered by the Board of Commissioners with his company, the Commissioners holding that a 50% payment of the total cost would be the only basis on which an adjustment would be made.

The Commissioners Ordered: That the residents of Columbus County shall not be charged a license fee to fish in any waters lying in the boundaries of the County.

Ordered: That a piece of property listed by Mrs. M. R. Thompson and known as the Milton Thompson place be allowed to remain on the tax books for 1928 at a valuation of \$1250.00 as approved in 1927 by the Board of Appraisers for Whiteville Township.

Ordered: That the following resolution be recorded relative to the expenditures of money received from the State on gas tax:

Be It Resolved by the Board of Commissioners of Columbus County:

That the Board of Commissioners request the State Highway Commission to apply Columbus County quota of County Aid Road Fund to the payment of bond interest and principal for the year beginning July 1, 1929, and until further notice, as provided in sub-section (d) of section 6 of the County Aid Road Act; and the Auditor is hereby instructed to furnish the State Highway Commission with necessary information in due time as to bond payments.

Motion placed by H. G. Avant with a second by J. R. Blake was unanimously

adopted by the Board of Commissioners ordering that the board for prisoners in jail shall be reduced from 75¢ to 50¢ per day per prisoner, and that this reduction shall be in effect on June 1, 1929, Mr. Burney is to be immediately notified of this order.

Ordered: That a new lawn mower be purchased for use by the Janitor on the Courthouse grounds.

Ordered: That the Tax Collector refund G. F. Best in Bug Hill Township for the year 1928 on \$1000.00 valuation on account of selling 91 acres by Best to D. M. Cox at that valuation, for which amount Mr. Best has never been relieved.

Ordered: That the Tax Collector refund A. J. Love in Chadbourn Township on poll tax for 1928 on account of the fact that he is disabled and over age.

Ordered: That the Tax Collector refund L. W. Russ of South Williams Township on poll tax for 1928 on account of his being disabled.

Ordered: That the Tax Collector refund W. B. Nobles in Chadbourn Township on poll tax for 1928 on account of Mr. Nobles living in Waccamaw but having been charged with poll in Chadbourn and Waccamaw Townships.

Ordered: That the Tax Collector refund J. T. McPherson in Williams Town-ship for 1928 on \$300.00 valuation on account of his being charged with tax on his personal property which was charged to and paid by A. D. McPherson.

Ordered: That the Tax Collector refund L. E. Reaves in Bug Hill Township for 1928 on \$200.00 valuation on account of 20 acres being listed by Dr. P. O. Schallert and also charged to L. E. Reaves through error.

Ordered: That the tax valuation on two town lots in Bolton Township listed under the name of Judge T. Monk be divided as follows: one lot with house now owned by J. H. Rehder be valued at \$1000.00. One blank lot now owned by Monk be valued at \$200.00. Said two lots are now charged to Monk at \$1200.00 valuation. It is further ordered, that J. H. Rheder be charged with \$800.00 valuation on said Monk lot for each of the years 1927 and 1928 on the 1928 tax rate, and that Judge T. Monk, or Lillie Monk, be released of the charge now standing against him on the tax books in the same amount for which J. H. Rheder is charged in both the years 1927 and 1928.

Ordered: That the following land sale certificates in the hands of Lewis and Baldwin be cancelled in the various amounts and years and for the reasons as set out below:
