The Honorable Board of County Commissioners met in their said office on Saturday, June 15, at eleven o'clock according to adjournment. All members of the Board were present.

The meeting of the Board at this time was to discuss the issuance of \$50,000.00 in notes, the details of which issue are set out in the following resolution:

Ordered, that the following resolution be recorded relative to borrowing of \$50,000.00 for General School purposes:

Be it ordered by the Board of County Commissioners of Columbus County that two notes of the County of Columbus be executed in the aggregate amount of FIFTY THOUSAND (\$50,000.00) DOLLARS to be in denominations of TWENTY-FIVE THOUSAND (\$25,000.00) DOLLARS each, dated June 25, 1929, after date, and bearing interest at the rate of 6% per annum interest payable at maturity; both principal and interest payable to BEARER at the Bank of Whiteville of the City of Whiteville, North Carolina, in anticipation of 1928 taxes, and that said note be sold or hypothecated and the proceeds

thereof turned into the General Fund of said County of Columbus.

Be it further resolved: That the full faith and credit of the County of Columbus be pledged to the punctual payment of the principal and interest of said notes at maturity.

The Commissioners discussed the feasibility and advantage of holding a four-days meeting beginning July 8 in accordance with the law for the purpose of hearing taxpayers who have tax matters to discuss with the Board. It was finally ordered that the Commissioners would hear the taxpayers who have complaints from Tatum, Waccamaw, Welches Creek, and Western Prong on

Monday, July 8; those from Bogue, Bolton, Lees, and Ransom on Tuesday, July 9; those from Bug Hill, Chadbourn, and Whiteville on Wednesday, July 10; and those from Cerro Gordo, Fair Bluff, Williams, and South Williams on Thursday, July 11. It was also ordered at this meeting that a notice be printed in the newspaper setting out the days on which persons from certain townships should appear before the Board and that the list-takers for the various townships be summoned to be present on the respective day in order to aid in the tax adjustments. It was understood by the members of the Board that all tax matters relative to 1929 valuation should be adjusted on these days, otherwise the Board will not entertain a complaint filed by any taxpayer at a later meeting.

At 12:10 P. M. the meeting of the Board was adjourned until Wednesday, June 19, 1929, at 2 P. M.
