The Honorable Board of County Commissioners held their regular monthly meeting in the Commissioners' office of the Courthouse on Monday, August 5, 1929. Members of the Board present were:

After the Board heard the reading of the minutes of the last meeting and passed their approval on same the following business was transacted:

Ordered: That the hospital expenses of James Vernon colored, in the amount of \$70.00 be paid.

Ordered: That the matter of adjusting 1929 taxes regarding reduction of valuation be held open through the date of this meeting in order to give any taxpayer who may appear before the Board on this date an opportunity of being heard relative to valuation reduction. The foregoing motion was placed before the Board by H. G. Avant and seconded by J. R. Blake. Those voting for the motion were: H. G. Avant, J. R. Blake, D. W. Merritt, and J. C. Hooks, Sr.; no, D. F. McGougan.

Ordered: That the 1929 valuation on Sam J. Wright's property in Waccamaw Township be further reduced from \$1500 to \$750. This reduction was granted in order to place the original valuation on this property. The foregoing motion was placed by J. R. Blake and seconded by D. W. Merritt. "For": J. R. Blake, D. W. Merritt, H. G. Avant; "against": D. F. McGougan, and J. C. Hooks, Sr.

Ordered: That the 1929 valuation on the property owned by Theo G. Empie in Lees Township be further reduced by \$4,050.00 leaving the present valuation to stand at \$950.00. This reduction was granted on account of the cutting of timber and over-valuation.

Ordered: That the Land Sale Certificate on the property of I. J. Stephens in Bug Hill Township for the year 1927 be reduced by the amount arising from a reduction of \$8100.00 in the valuation at the tax rate for that year, amount of refund being \$157.85. It is further ordered that when payment is tendered for the 1928 tax a like refund is to be allowed on \$8100.00 at the 1928 tax rate, amount of refund being \$160.32. The refund on these two years is allowed on account of an error in charging Stephens with \$9,000.00 when the valuation originally was \$900.00.

Ordered: That the Land Sale Certificate on the property known as the E. F. Powell, Est., for the year 1928 be reduced by the amount arising



from a \$1700.00 valuation, reduction at the 1928 tax rate, the amount of the reduction being \$29.75. The adjustment on this tax is made on account of E. F. Powell, Est. being charged with four lots at \$2200.00 when there are only two lots, the other two being listed by S. T. Weaver. The two lots of the E. F. Powell, Est. are to carry a total valuation of \$500.00.

Ordered: That the 1929 valuation on the property owned by Mrs. E.

J. Britt in Chadbourn Township be reduced from \$1750.00 to \$1500.00. It

is further ordered that the 1929 valuation on three lots owned by E. J. Britt in Chadbourn Township be reduced from \$9000.00 to \$7000.00. These reductions are granted on account of over-valuation. The foregoing motion was placed before the Board by H. G. Avant and seconded by J. R. Blake. Those voting for were: J. R. Blake, D. W. Merritt, H. G. Avant; against: J. C. Hooks, Sr., D. F. McGougan.

Ordered: That the 1929 valuation on the property of F. T. Wooten, Jr. in Chadbourn Township be raised from \$1750.00 to \$2750.00, the increase in valuation being ordered on account of improvements which resulted in an undervaluation.

Ordered: That John Hawes be admitted to the County Home for three weeks.

Ordered: That the drug bill of Albert Rogers as prescribed by Dr. Cox at Harrelson's Pharmacy be paid by the County and that in case of death it is hereby ordered that D. F. McGougan is to purchase a burial case not to exceed \$20.00 in cost.

It was ordered by the County Commissioners: That that portion of Cherry Grove-Evergreen County Highway which runs through the town of Cerro Gordo be maintained by the County road force which is operating on that road in accordance with the following order as passed by the Board of Town Commissioners of Cerro Gordo:

Ordered, by the Board of Town Commissioners of the Town of Cerro Gordo that the Board of County Commissioners of Columbus County be requested to take over and maintain in the same manner as it maintains the Cherry Grove-Evergreen county highway that portion of said Cherry Grove-Evergreen county highway which runs through the Town of Cerro Gordo;

Ordered further that the Town of Cerro Cordo pay the said County of Columbus the sum of \$50.00 per year for maintenance of said road, there being about ensichalf mile of said road, in the event the County Commissioners see fit to take over and maintain said road.

(Ordered: That the following resolution be recorded:)

Ordered, that the following resolution be recorded relative to borrowing \$40,000.00 for the purpose of erection and purchase of school houses in Columbus County:

Be it ordered by the Board of County Commissioners of Columbus County that four notes of Columbus County be executed in the aggregate amount of FOURTY THOUSAND DOLLARS (\$40,000.00) to be in denominations of TEN THOUSAND DOLLARS (\$10,000.00) each, dated August 13, 1929, maturing ninety days after date and bearing interest at the rate of 6% per annum payable at maturity, both principal and interest payable to BEARER at the Bank of Chadbourn of the City of Chadbourn, North Carolina, in anticipation of the receipts of the proceeds of the sale of bonds authorized July 1, 1929, and the proceeds thereof turned into the General Fund of said County of Columbus.

Be it further resolved that the full faith and credit of the County of Columbus be pledged to the punctual payment of the principal and interest of said notes at maturity.

A motion to adopt the following resolution was placed by H. G. Avant and seconded by D. W. Merritt. Those voting "for": D. F. McGougan, J. C. Hooks, Sr., J. R. Blake, D. W. Merritt, H. G. Avant; against: None.

The following order was introduced and on motion by J. R. Blake, seconded by D. W. Merritt was unanimously carried:

Whereas a petition signed by at least 200 resident freeholders of Columbus County, of which at least 150 are not residents of the City of Whiteville, asking that an annual tax may be levied, has been filed with the Board of County Commissioners in the following form: "The undersigned resident freeholders of the County of Columbus, North Carolina, pursuant to section 7255 of the Consolidated Statutes, hereby ask that an annual tax may be levied for the establishment and maintenance of a public hospital in or near the City of Whiteville in said county, the maximum amount of money proposed to be expended in purchasing or building such hospital being \$100,000.00, of which \$50,000.00 will be contributed by the Duke Endowment Fund if the County will contribute the other \$50,000.00."

Therefore it is

ORDERED, pursuant to section 7255 and 7256 of the Consolidated Statutes, that the question of levying said tax shall be submitted to the qualified electors at a special election which is hereby called for that purpose, to be held on the 30th day of November, 1929, at the usual places in the county for electing officers, and a new registration therefor is hereby ordered. The said tax shall be at the rate of not exceeding 1/15 of 1 cent on the dollar and shall be levied for a period of 30 years, The ballots at such election shall be in substantially the following form:

County to a maximum aggregate principal amount of \$50,000 be issued for the
purpose of purchasing real estate for hospital purposes and for constructing
hospital buildings thereon. The said buildings shall be of fireproof construction
struction as defined in the County Finance Act.

A tax sufficient to pay the principal and interest of the said bonds when due shall be annually levied and collected.

A statement of the County debt has been filed with the clerk and is open to inspection.

This order shall take effect when approved by the voters of the county at an election as provided in the County Finance Act.

The vote on the foregoing order was as follows:

The following resolution was introduced and on motion by Mr. Blake, seconded by Mr. Merritt was unanimously carried:

Resolved that the foregoing order be published pursuant to section 16 of the County Finance Act and the 19th day of August, 1929 at 10:00 o'clock A. M. is hereby fixed as the day and hour for a public hearing thereon.

The vote on the foregoing resolution was as follows:

Ordered: That the following Notice of Election in Whiteville Township Special Taxing District No. 8 be recorded:

Whereas, the County Board of Education of Columbus County has defined and recorded in the minutes of the Board of Education the boundary lines of Whiteville Township Special Taxing District No. 8 known as Whiteville Township Special Taxing District No. 8.

And, whereas, a petition signed by more than twenty-five voters who reside within this special taxing district petitioning the County Board of Education for a special school tax of not to exceed thirty cents on the hundred dollars valuation of property real and personal, has been filed with said Board and the said petition for an election having been approved by the County Board of Education of Columbus County.

Now, therefore, notice is hereby given that an election will be held in Whiteville Township, Special Taxing District No. 8, on the 10th day of September, 1929, to ascertain the will of the people within said school taxing

district as to whether there shall be levied in said district a special annual tax of not more than thirty cents on the one hundred dollars valuation of property, real and personal to supplement the public school which may be apportioned to said district by the Board of Education, the boundary lines of said district being as follows, to-wit:

Beginning at the run of Diamond Branch in the Plank Road, thence down said branch to H. M. Walker's line, then his line northward to J. M. Walker (deceased) line, then his line so as to include his land, then to Soldiers Swamp, thence up Soldier Swamp to the mouth of the Five Mile Branch, thence up Five Mile Branch to the Pine Level District Line, thence with said line to Beaver Dam Swamp, then down said swamp to Boggy Branch, then with said branch to the margin of Big Bay, then following said margin of Big Bay in a southeast direction to the lands of Ira Sasser, deceased, thence with said line to Callie Sasser's line and then including his lands to the Marsh Swamp, then up said swamp to the mouth of Camp Branch and up said branch so as to include D. P. Gore's land and also D. N. Evan's land to the B. W. It is ordered that another registration of the qualified voters of Whiteville Township Special Taxing District No. 8 shall be had. The polling place in the said district shall be at Nealy's Store. Registration books will be open on the 10th day of August, 1929, and will close on the 31st of August. S. Leo Nealy is hereby appointed Registrar for said election and J. L. Harrelson and Asa L. Ward are hereby appointed poll holders for said election. The said Registrar shall attend the polling place on August 10th, 17th, 24th and August 31st, 1929, for the registration of voters. The registration books shall be open for registration of voters at all times between the 10th day of August, 1929, and the 31st day of August, 1929, both inclusive. The 7th day of September, 1929, shall be challenge day and the said registrar and poll holders shall attend the polling place on said day for the purpose of receiving challenges. Said election shall be held on the 10th day of September, 1929.

At the election those who are in favor of a special tax of not to exceed thirty cents on the one hundred dollar valuation of property, real and personal, shall vote a ticket on which shall be printed or written words "For Local Tax," and those who oppose the same shall vote a ticket on which shall be written or printed the words, "Against Local Tax".
