The Honorable Board of County Commissioners met in the Commissioners' office in an adjourned session on Thursday, October 10, 1929, all members of the Board being present. The following orders were passed by the Board during this meeting:

Ordered: That A. A. Williams, Clarendon, N. C., be allowed \$5.00 present relief from the Outdoor Poor fund.

Ordered: That J. W. Ward, who presented certificate signed by school committee certifying that he does not live in special school District No. 10 of Lees Township be refunded in the amount of \$11.60 as special school tax for the year 1927. It is further ordered that at whatever time J. W. Ward pays his tax for the years 1928 and 1929, he be refunded in the amount of special school tax charged to him in the respective years.

D. L. Gore, Tax Collector, submitted his two bonds as required by law in the aggregate amount of \$60,000.00 to the County Commissioners subject to their approval. Said bonds were accepted by the Board of Commissioners and same were ordered to be filed with the Register of Deeds for recording. The tax books for the year 1929 were then delivered to the Tax Collector.

A letter filed with the Clerk to the Board of Commissioners by a representative of the Columbus County News, a newspaper printed at Chadbourn, N. C., was read to the Board by the Chairman. The purpose of the letter was to ask the County Commissioners to consider the Columbus County News when the notices of foreclosure were published, especially those notices concerning land situtated in the territory over which the Columbus County News has its largest circulation. The letter also contained a bid made on a flat-rate basis for such advertising, the bid being approximately one-half of the amount being paid at present to the News Reporter. and motion was placed before the Board by D. W. Merritt, seconded by J. C. Hooks, Sr. to have all the publishing of foreclosure notices made through the News Reporter as heretofore inasmuch as the News Reporter has a paid-inadvance subscription of approximately 2400 as against a circulation for the Columbus County News of approximately 600. It was also pointed out that when the Court appointed a commissioner in the suit, it was his duty to place the notice in a newspaper which would be likely to give notice, on account of its circulation, to the most people concerned, the cost of the advertising to be included in the foreclosure cost, same to be paid by the purchaser of the land and not to become an expense to the County. A vote was taken on the foregoing order, the record being as follows: Against making a change, D. W. Merritt, J. C. Hooks, Sr., H. G. Avant, D. F. McGougan; for making a change, J. R. Blake. The motion was carried in favor of having the advertising made through the News Reporter in the future as in the past.

Ordered: That the Sheriff summon the following good and lawful men to serve as jurors during the term of Civil Court beginning November 18, 1929.
