"Whereas, sufficient taxes have not been collected to pay appropriations made for the current fiscal year in Columbus County, and a temporary loan is necessary to meet such appropriations,

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Columbus County, North Carolina, that said County borrow, and be authorized to borrow, on the faith and credit of said County, as provided in Section 4 of 'The County Finance Act,' the sum of Twenty-five Thousand Dollars (\$25,000.00) for the purpose of raising funds to meet the appropriations made for ordinary expenses of said County, and the Chairman of this Board be and is hereby suthorized to execute a note in the aforesaid sum, dated August 20, 1930, payable to bearer, signed by the said Chairman and attested by the Clerk to the Board, payable on the first day of November, 1930, and bearing interest at the rate of $4\frac{1}{4}$ per cent per annum, and that such note be negotiated and delivered by the said Chairman for the purposed of aforesaid."

It is further ordered that bids be received regarding the sale of said County note in order to get as low rate of interest as possible on said loan.

Ordered: That Lena Williamson's name be dropped from the Outdoor Poor list and that she be admitted to the County Home.

The N. C. Bank and Trust Company of Wilmington, N. C., formerly operating under the name of Murchison National Bank, is desirous of having the surety bond which Columbus County holds in the amount of \$160,000.00 covering deposit of County sinking funds in said bank, returned to them for cancellation/and in lieu thereof issue to Columbus County another surety bond in the amount of \$100,000.00 which amply covers the actual deposit balance of \$91,705.06 as of August 15, 1930, it being understood by said N. C. Bank and Trust Company that said bond in the amount of \$160,000.00 be held to cover said County deposit until such date as the \$100,000.00 bond has been executed and delivered to the Board of County Commissioners of Columbus County. It was ordered by the Board that said \$160,000.00 bond be returned to the said N. C. Bank and Trust Company in accordance with said bank's request.
