Two notes which Eyer & Company of New York City now hold mature on December 22, 1930. Since funds are not available with which to retire same and Eyer & Company having notified the Board that they were unable to renew the notes, the Commissioners passed the following resolution relative to renewing the notes of Columbus County in the sum of \$50,000.00 for General School purposes:

"Be it ordered by the Board of County Commissioners of Columbus County that two notes of the County of Columbus be executed in the aggregate amount of FIFTY THOUSAND DOLLARS (\$50,000.00), to be in denominations of TWENTY°FIVE THOUSAND DOLLARS (\$25,000.00) each, dated December 22, 1930, after date, and bearing interest at the rate of six per cent per annum, interest payable at Maturity; both principal and interest of one note payable to BEARER at the Waccamaw Bank & Trust Company of the City of Whiteville, North Carolina, and both principal and interest of the other note payable to BEARER at the North Carolina Bank & Trust Company of the City of Wilmington, North Carolina, in anticipation of 1930 taxes, and that said note be sold or hypothecated and the proceeds thereof turned into the General Fund of said County of Columbus.

BE IT FURTHER RESOLVED: That the full faith and credit of the County of Columbus be pledged to the punctual payment of the principal and interest of said notes at maturity."

The required advertisement as provided in the County Finance Act has been published relative to this loan in the News Reporter, a newspaper published in Columbus County.

Upon motion of D. W. Merritt, seconded by C. D. Garrell, th

foregoing resolution relative to renewing two \$25,000.00 notes was adopted the following Commissioners voting in the affirmative: J. C. Hooks, <sup>S</sup>r., D. W. Merritt, J. R. Blake, C. D. Garrell, R. C. Benton.

It appearing from notices received from the Banks that Several Townships are past due at the Waccamaw Bank & Trust Company, upon motion by D. W. Merritt, seconded by J. R. Blake, which motion was carried by a unanimous vote by the Board the following Township road notes were ordered renewed except where funds were available, it was ordered that notes be paid:

Cerro Gordo Township Note dated Dec. 1, 1930, \$500.00 due in four months. Ransom Township Note dated Nov. 5, 1930, \$2500.00 due two months. Ransom Township Note dated Nov. 10, 1930, \$1400.00 due in four months. Tatum Township Note dated Nov. 10, 1930, \$500.00 due in four months. Tatum Township Note dated Dec. 5, 1930, \$100100 due in three months. Williams Township Note dated Nov. 29, 1930, \$500.00 due in four months. Waccamaw Township Note dated Nov. 25, 1930, \$300.00 due in two months. Lees Township Note dated Nov. 10, 1930, \$900.00 due in four months.

There being no further business to come before this meeting, adjournment was voted in order until Monday, December 8, 1930.
