Ordered: That the employing of Miss Blanche Penny in the office of School Superintendent be deferred until the expiration of her present contract.

Ordered: That J. D. Lewis be appointed County Attorney at a salary of \$75.00 per month.

Ordered: That Jackson Greer be appointed as County Solicitor for Recorder's Court at a salary of \$75.00 per month.

Ordered: ~~That~~ Ed A. Maultsby, Judge of Recorder's Court, salary be \$75.00, per month.

Ordered: That C. A. Farley, Deputy Sheriff, be hired at \$100.00 per month.
