Minutes of last meeting being read and approved the following business was transacted:

Ordered: That the valuation of A. Z. Thompson in Whiteville Township be reduced from \$3800.00 to \$3000.00.

Ordered: That the Sheriff and Deputies be paid five cents per mile each way for conveying prisioners and \$1.00 per day in cases where the County is liable for the cost.

Ordered: That the Sheriff be notified not to use any officer except Ed Schwartz for Recorder's Court without further orders from the Board.

Ordered: That 0. V. Powell be allowed \$2.50 present relief and \$2.50 per month until further ordered:

Ordered: That \$750.00 be put in County budget as of June 30, 1932, for the County's proportionate part of N. C. Forest Service.

Ordered: That the Tax Collector be notified to deposit with the Waccamaw Bank & Trust Company, Bolton Drainage funds which he collects until first Monday in March, 1932, said funds are to be covered by Bond now in force with the said Waccamaw Bank & Trust Co.

Ordered: That \$50,000.00 Columbus County note now in the North Carolina Bank & Trust Company made payable to BEARER at Waccamaw Bank & Trust Company and held by North Carolina Bank & Trust Company be placed there by Waccamaw Bank & Trust Company as security for deposits in the said Waccamaw Bank & Trust Company be released, and in lieu thereof renewal notes in the sum of \$50,000.00 be placed with said North Carolina Bank & Trust Company in place of the said \$50,000.00 note.

Be it ordered by the Board of County Commissioners of Columbus County that Columbus County note in the sum of \$50,000.00 made payable to BEARER at North Carolina Bank & Trust Company, Wilmington, N. C. and now being held by Wilmington Savings & Trust Company of Wilmington, N. C., as security for deposits on hand in North Carolina Bank & Trust Company; the reason for said release being that the said \$50,000.00 notes have been satisfied by a renewal of \$40,000.00 of said sum and a \$10,000.00 payment, and that the renewal notes for the sum of \$40,000.00 will be placed by North Carolina Bank & Trust Company in the Wilmington Savings & Trust Company, subject to the order only of Columbus County.

Ordered: That Mrs. Agnes Bamhardt, Welfare Officer be paid \$800.00 Salary and \$150.00 traveling expense as per agreement in August, 1931.

Whereas, a petition has been filed with the Board of County Commissioners of Columbus County by certain citizens of Lees Township, asking said Board to request the State Highway Commission of North Carolina to take over and maintain a certain road known as the old "Big Island" Public Road, leading from Old Dock Postoffice in a Westerly direction to the "Big Island" and Mark Pine road at Cypress Creek Church, near Randall Ward's home place, a distance of about two and three-fourths miles; and

Whereas, said road saves about half the distance that is necessary in Travelling another road known as "The Elbow", which it is necessary to use instead of the road above referred to:

Now, therefore, Be It Resolved by the Board of County Commissioners of Columbus County that the State Highway Commission be requested to take over and maintain the road above described; and

Be It Further Resolved that a copy of this resolution be sent to the State Highway Commission, and a copy recorded on the minutes of this Board.

Whereas, certain citizens and tax payers of South Williams
Township have petitioned the Board of County Commissioners of Columbus
County to request the State Highway Commission to take over and maintain
two and seven tenths (2.7) miles of road, leading from the Tabor and
Pireway road at or near James Porter's place and runs to the old Conway
and Whiteville Road, intersecting the said Conway and Whiteville Road,
at or near the Joyner Place; and

Whereas, Columbus County maintained the said road for a period of seven years, and maintained the same up to the time the State took over the County roads; and

Whereas, this is an important road in that school busses use the said road regularly in conveying children to the Tabor School: Now, therefore, Be It Resolved by the Board of County Commissioners of Columbus County that the State Highway Commission be requested to take over and maintain the said road; and

Be It Further Resolved that a copy of this resolution be sent to the State Highway Commission at Raleigh, and a copy recorded on the minutes of this Board.

Whereas, certain citizens of Cerro Gordo Township have petitioned the Board of County Commissioners of Columbus County to request the State Highway Commission to take over and maintain a certain road about two miles in length, which leads from Dan Batten's line and runs in a Southwesterly direction by the J. P. Hammond, Coy Blackwell, Monroe Howell and other places, to the Conway Road;

And whereas, there are from twelve to fifteen families living on said road, which said road was formerly maintained by Columbus County, but was not placed on the State Highway map;

Now, therefore, Be It Resolved by the Board of County Commissioners of Columbus County that the State Highway Commission be requested to take over and maintain the said road as early as possible;

And Be it further resolved that a copy of this resolution be sent to the State Highway Commission at Raleigh, and a copy recorded on the minutes of this Board.

Whereas, certain citizens of Cerro Gordo Township have petitioned the Board of County Commissioners of Columbus County to request the State Highway Commission to take over and maintain a certain road leading from I. L. Green's place to Carey Todd's place in Cerro Gordo Township, being about one and one-half miles in length:

Now, therefore, be it resolved by the Board of County Commissioners of Columbus County that the State Highway Commission be requested to take over and maintain the said road as early as possible:

And be it further resolved that a copy of this resolution be sent to the State Highway Commission at Raleigh, and a copy recorded on the minutes of this Board.

Whereas, certain citizens of Columbus County have requested the Board of County Commissioners to petition the State Highway Commission to take over and maintain a road North of Whiteville, beginning at a point near L. George's leaving Highway # 23 and running in a

northerly direction to where it intersects with the Elizabethtown and Fair Bluff road; and

Whereas, this road is deemed and important road in Columbus County and serves many people.

Now, therefore, be it resolved by the Board of County Commissioners of Columbus County that the State Highway Commission be requested to immediately take over and maintain the said road above described.

Be it further resolved that a copy of this resolution be sent to the State Highway Commission at Raleigh and a copy recorded on the minutes of this Board.
