On motion R. C. Benton, seconded by C. D. Garrell that nothing be provided in 1932 tax budget for fire protection except \$750.00 which was formerly agreed to.

Ordered: That voucher be given to Mrs. Charlie Stewart to pay her 1929 taxes.

On Motion R. C. Benton seconded by C. D. Garrell that the Jailor be paid 35¢ per day for feeding prisoners at the Jail to take effect July 15, 1932.

On motion C. D. Garrell, seconded by R. C. Benton that no appropriation be made for Home Demonstration work in 1932 budget. Voting Yes: Garrell & Benton. Voting No: Blake, Merritt & Hooks.

On motion C. D. Garrell, seconded by R. C. Benton that a levy of .01 be made for Co-operative Health work.

On Motion of D. W. Merritt, seconded by J. R. Blake that \$1500.00 be appropriated for Farm Demonstration work with the understanding that the office be kept open as much as possible, contract to be dated July 1, 1932. Voting Yes, Merritt, Blake & Hooks. Voting no, Garrell and Benton.

On motion D. W. Merritt, seconded by J. R. Blake that \$600.00 be appropriated for White Home Demonstration Work. Voting yes, J. R. Blake, D. W. Merritt & J. C. Hooks, Sr. Voting no, C. D. Garrell and R. C. Benton.

On motion D. W. Merritt, seconded by J. R. Blake that \$180.00 be appropriated for colored Home Demonstration work. J. C. Hooks, Sr., J. R. Blake, D. W. Merritt voting yes. C. D. Garrell & R. C. Benton, voting no.

On motion J. R. Blake and seconded by D. W. Merritt that \$600.00 salary and \$150.00 traveling expense be appropriated for Welfare Officer. Yes, J. R. Blake, D. W. Merritt, J. C. Hooks, Sr. No, R. C. Benton, and C. D. Garrell.

The meeting was then adjourned until July 15, 1932.
