Minutes of last meetings being read and approved the following business was transacted:

Ordered: That J. K. Council and wife be allowed to deed the County a lot in the town of Chadbourn adjoining the Chadbourn High School property, and that they be allowed as consideration therefor the sum of \$400.00, the said \$400.00 to be credited on notes of J. K. Council & wife to Julian D. Lewis, Trustee, for the Board of County Commissioners of Columbus County.

Ordered: That E. S. Nance be allowed to pay his 1929 taxes without interest or Court Cost.

Ordered: That Julian D. Lewis be notified to make deed to Estelle I. Baldwin for the G. A. Norwood land in Chadbourn Township for amount of tax which is \$585.00. It is further ordered that Estelle I. Baldwin & husband be allowed to make deed of trust to County for \$585.00 to be paid annually of \$117.00 each payment plus 6% interest.
