Minutes of the last meeting being read and approved, the following business was transacted:

ORDERED: That a horizontal reduction of 10 percent on real estate in Columbus County be made in accordance with the provisions of the 1933 Machinery Act, the said reduction to affect the valuations for the year 1933, and the years thereafter, until further change is made by Law or by the Board of County Commissioners according to Law. This order is made in accordance with Article 4 Section 1 of the 1933 Machinery Act, which gives said Board option of horizontal increase or reductions or general valuation.

Ordered: ^{HAT} That the County Attorney be directed to advertise the lands described in a judgement in the matter of "Columbus County vs. J.C. Williamson et als" and sell the same at the Court House door of Columbus County, according to law, to the highest bidder for cash. But in the event Columbus County becomes the last and highest bidder, then it is agreed that

a certain tract of land will be conveyed by said County to a purchaser designated by J.R. Williamson, provided the sum of \$ 225.00 be paid Columbus County on said taxes. The said land to be sold in consideration of payment of \$ 225.00 on taxes is known as the Piney Bay Tract land in Cerro Gordo Township, and containing 7 acres, more or less.

It is further ordered that W.W. Baldwin, auditor, arrange with the lowest bidder, either the News Reporter or Columbus News, for the advertisement of said lands.

In accordance with and under the provisions of an Act of the General Assembly, Session 1933, being Senate Bill # 180, it is ordered that tax payers as a condition precedent to taking advantage of Article 1 of said Act, providing for payment in five annual installments of taxes for the year 1927-1931 inclusive, that said taxpayer shall be required to pay taxes for the year 1932 on all his real and personal property in Columbus County.

Whereas, certain citizens of Columbus County have petitioned the Board of County Commissioners of Columbus County to request the State Highway Commission to have some work done on the road leading from Lennon's Cross Roads Church via W.I. West's field across Rattlesnake Branch and connecting with the Bladenboro-Evergreen Road at the Bladen County line at Wilbur Brown's; and

Whereas, the said citizens set out in their petition the reasons for having work done on the road:

Now, therefore, Be It Resolved by the Board of County Commissioners of Columbus County: that the State Highway Commission be requested to have some work done on the above described road: and

Be It Further Resolved: that a copy of this resolution, together with the petition, be forwarded to the North Carolina State Highway Commission and a copy placed upon the minutes of this Board.

Whereas, certain citizens of Columbus County have petitioned the Board of County Commissioners of Columbus County to request the State Highway Commission to place upon the State Highway map as a Class "A" Road, the following road in Whiteville Township:

Beginning at or near Seymour Cook's residence on the Whiteville and Lumberton Road and intersects with the Elizabethtown and Fair Bluff Road at or near the Rose Hill Negro School House, a distance of about one mile.

Now, therefore, Be It Resolved by the Board of Commissioners of Columbus County, that the State Highway Commission be requested to take over and place on said State highway maps as a Class "A" Road, the said road above described; and

Be It Further Resolved: that a copy of this resolution together with the petition, be forwarded to the North Carolina State Highway Commission at Raleigh and a copy placed upon the minutes of this Board.

ORDERED: That T.H. Williams, A.H. Marks, and John Morris be appointed to investigate the alleged killing of the chickens of Bill Applewhite by the dog of H.W. Kaester, and report to Commissioner W.L. Hobbs their findings.

ORDERED: That the Waccamaw Bank and Trust Company, County Depository, be notified to charge the General School Fund Bank account with \$849.42 which is for Interest on General School Notes. This Order is passed on account of the Board of Education refusing to issue voucher to pay said interest.

There being no further business to come before the Board at this time, adjournment was voted in order until May 1st, 1933.
