WHEREAS, the Board of Commissioners of Brunswick and Columbus Counties met in joint session at New Brittain Bridge on July 1kth to discuss together the possibilities of having the State Highway Commission appropriate sufficient funds for the paving of Route No. 130 from South Port to Whiteville; and

Whereas, it was called to the attention of the Board that resolutions had already been passed by the two Boards separately asking for an appropriation on this same project; and

Whereas, it now appears that the two Boards working together can better represent their mutual interest by working together as a unit:

NOW THEREFORE, be it resolved that the Joint Boards respectfully request the State Highway Commission to carefully consider the petitions and resolutions heretofore adopted separately by the two Boards and that they investigate the merits of these petitions, and if necessary ask for additional information to the end that the proposed project will be given a very careful survey by the Highway Commission.

BE IT FURTHER RESOLVED, That the two Boards separately name a committee to represent the two Counties before the State Highway Commission; the Committee to be composed of seven, with four from Columbus and three from Brunswick.

Upon motion of Mr. W. L. Hobbs, seconded by Mr. R. C. Benton, the foregoing resolution was unanimously adopted, whereupon the two Boards retired and elected their committee.
