The Honorable Board of County Commissioners met in Joint Session with the Board of County Commissioners of Brunswick County July 11, 1933, at New Brittain Bridge. Members of the Board present:

The following business was transacted:

WHEREAS, the Board of Commissioners of Brunswick and Columbus Counties met in joint session at New Brittain Bridge on July 11th to discuss together the possibilities of having the State Highway Commission appropriate sufficient funds for the paving of Route No. 130 from South Port to Whiteville; and

Whereas, it was called to the attention of the Board that resolutions had already been passed by the two Boards separately asking for an appropriation on this same project; and

Whereas, it now appears that the two Boards working together can better represent their mutual interest by working together as a unit:

NOW THEREFORE, be it resolved that the Joint Boards respectfully request the State Highway Commission to carefully consider the petitions and resolutions heretofore adopted separately by the two Boards and that they investigate the merits of these petitions, and if necessary ask for additional information to the end that the proposed project will be given a very careful survey by the Highway Commission.

BE IT FURTHER RESOLVED, That the two Boards separately name a committee to represent the two Counties before the State Highway Commission; the Committee to be composed of seven, with four from Columbus and three from Brunswick.

Upon motion of Mr. W. L. Hobbs, seconded by Mr. R. C. Benton, the foregoing resolution was unanimously adopted, whereupon the two Boards retired and elected their committee. The representatives elected from Columbus County were: Messrs. W. H. Powell, H. L. Lyon, Knox Proctor, and Jackson Greer. The delegation elected from Brunswick were: Messrs. S. B. Frink, J. W. Ruark and R. I. Mintz.

WHEREAS, the Board of Commissioners of Brunswick and Columbus Counties met in Joint Session Tuesday, July 11th and discussed together the proposal of Messrs. Hobbs and Peterson with reference to a road from Bolivia, Brunswick County, to Delco, Columbus County, and

Whereas, it is the opinion of the Joint Boards that such a road would be of great benefit to the people of both counties and also to traffic going to and from the beaches from up-state;

and

Whereas, it was called to the attention of the Board that such a road would shorten the distance from Bolivia to points in Columbus County by approximately twelve miles:

NOW, THEREFORE, Be it resolved by the Joint Board in Session that the State Highway Commission be petitioned to make a careful investigation and report whether or not it will take over for maintenance such roads between Bolivia and Delco as now exist and connect the approximately five miles which now has no road.

There being no further business to come before the Board at this time, adjournment was voted in order until July 25th, 1933.
