Ordered: that J. K. Powell, Prosecuting Attorney for Recorder's Court, be paid for his services in said Court, \$4.00 for each conviction where cost is paid by defendant and \$2.00 for each conviction where road sentence is imposed, and he receives no fee where judgement of "Not Guilty" or Nol Pros is entered. This order to be effective as of April 1st, 1935.

It appearing that H. O. McCumbee is due Columbus County and Town of Chadbourn for taxes through and including 1932 covering home place and lot in Town of Chadbourn and also covering other lots sold to various parties and that in foreclosure by Columbus County and Town of Chadbourn, lots sold to other parties were sold for these taxes and these parties having paid their pro rata share of taxes and H. O. McCumbee having offered to give mortgage secured by first Deed of Trust for taxes on his home place and vacant lot, and;
