Upon motion of H. G. Avant, second of F. L. Formy Duval, motion carried. It is ordered that Julian D. Whereas, this Board is of the opinion that Columbus County would be materially injured by such a change in that it would take a large amount of traffic almost out of the county, would hinder business not only for the public in general, but particularly for those who have located businesses on the highway with the special view of having the patronage of tourists on Highway # 20; and,

Whereas, this County has always co operated with the State Highway Commission, has never had it's county seat connected with the county seat of Brunswick County, being thus deprived of a highway which practically every other county in the State has had advantage of, but said county has and continues to co operate with the State Highway Commission; and,
