Minutes of the last meeting being read and approved, the following business was transacted.

Ordered: that Neil Barefoot be allowed \$4.00 present relief and \$4.00 per month.

Ordered: that L. W. Graves allowance be increased to \$4.00 per month.

Ordered: that C. S. Sasser be and he is hereby appointed Constable of Bogue Township in the place and stead of Garland Ward who has refused to make the bond and qualify as required by law.

Ordered: that William Foeman's wife be allowed to pay 1929-1930, and 1931 taxes at face amount of land sales certificates plus court cost.

Ordered: that Tax Lister of Whiteville Township be allowed to reduce Seth L. Smith 1935 tax list \$600.00 on account of house being moved from Blanche Hickman lot.

Ordered: that J. A. Speigle be allowed to peddle in Columbus County without paying license until September 1st, 1935, on account of his being disabled a/World War Veteran.

Ordered: that Mrs. Johnsie Nunn's salary be increased to \$75.00 per month and travel \$25.00, to be as of April 1st, 1935.

Ordered: that William Berkley Estate 1933 and 1934 taxes be separated so Virginia Berkley may pay her part of tax which is taxes on \$1,100.00 valuation.
