The following business was transacted.

Ordered: that W. & A. Leonard's 1934 taxes be separated so Standard Oil Company may pay taxes on lot which they hold mortgage on.

Ordered: that persons, firms or corporations owing Columbus County 1932 or prior taxes be allowed to pay said taxes by paying 10% provided said taxes are paid on or before December 1st, 1935.
