ORDINANCE OR RESOLUTION FIXING MINIMUM WAGE RATES.

WHEREAS, a thorough investigation has been made of the hourly wage rates which are being paid in the Town of Whiteville, and Columbus County, N. C. which is the locality in which the proposed project (hereinafter referred to as "Project") is to be constructed by the County of Columbus, to employees in each trade or occupation engaged in work of a nature similar to the work to be performed in the construction of said Project, and the prevailing hourly wage rates being paid in such locality to such employees for such work have been determined by said County Commissioners by conferring with contractors and mechanics in the locality.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the County of Columbus that the following rates for the respective trades or occupations listed below shall be and are hereby fixed as the minimum hourly wage rates and have been determined in accordance with rates prevailing for work of a similar nature in the locality in which the project is to be constructed.

BE IT FURTHER RESOLVED that the foregoing list of trades or occupations includes to the best of our knowlddge, all the classifications of employees who will be engaged in work on saod Project other than executive, supervisory, administrative, clerical or other non-manual workers as such.
