After calling the meeting to order and after the Clerk had called the roll, the Members of the Board of Commissioners for the County of Columbus who were present sat at the table at which the County Board of Elections was holding its meeting, and thereupon said County Board of Elections and said Board of Commissioners, as two separate bodies, separately received from the Registrars and Judges of Election in the various preceints of the County of Columbus the returns of the special bond election held February 7th, 1939.
