REVENUE ANTICIPATION NOTE

The County of Columbus, in the State of North Carolina, hereby acknowledges itself indebted and for value received promises to pay to the bearer hereof in lawful money of the United States of America the sum of Twenty Five Thousand (\$25,000.00) Dollars on July 30, 1939, together with interest thereon from date hereof at the rate of 1-1/2% per annum, payable upon presentation of this note at its maturity. Both principal^{of} and interest on this note are payable at Wachovia Bank and Trust Company, Winston Salem, North Carolina. For the prompt payment hereof, both principal and interest as the same fall due, the full faith and credit of the County of Columbus are hereby irrevocably pledged.

This note is issued in pursuant to the County Finance Act, as amended, and a resolution duly adopted by the Board of County Commissioners of said County for necessary expenses and for the purpose of meeting appropriations of the current fiscal year.

IT IS HEREBY CERTIFIED AND RECITED that all acts, conditions and things required by the laws and Constitution of North Carolina to be performed, happen and exist precedent to and in the issuance of this note have been performed, have happened and exist, and that this note is within every debt and other limit prescribed by said laws and Constitution.

IN WITNESS WHEREOF, the County of Columbus has caused this note to be signed by the Chairman of its Board of Commissioners and attested by the Clerk of said Board and its corporate seal to be impressed hereon this 20th day of April, 1939.

There being no further business to come before the Board at this time, adjournment was voted in order until May 22nd, 1939.

Ordered: that the Tax Collector issue license to Isabella Martin to retail beverages as provided in the "1933 Beverage Control Act" as amended.

Ordered: that C. A. Small, Chairman, sign \$55,000.00 Columbus County Hospital Bonds and that Mrs. Lila Mae Powell be authorized to take said bonds to Raleigh and deliver to Local Government Commission and take receipt for same.

Ordered: that S. B. Newell's valuation in Chadbourn Township be fixed at \$500.00 for 1938 and prior years and he be allowed to pay said tax due at par and \$3.00 for each suit.

There being no further business to come before the Board at this time, adjournment was voted in order until May 29th, 1939.
