C RESOLUTION

Ordered: that the following resolution be recorded relative to borrowing Thirty Thousand (\$30,000.00) Dollars for General County purposes, same being renewal note.

Be it ordered by the Board of County Commissioners of Columbus County that one note of the County of Columbus be issued in the sum of Thirty Thousand (\$30,000.00) Dollars for General County purposes, said note dated August 1st, 1940, maturing December 1st, 1940.

The above note bearing interest at the rate of one and one-half percent (1 1/2%) per annum, interest payable at maturity; both principal and interest of said note payable to BEARER at Chase National Bank in the City of New York, N. Y. in anticipation of 1939 taxes, and that said note be sold or hypothecated and the proceeds thereof turned into the General Fund of the said County of Columbus

Be it further ordered that the full faith and credit of the County of Columbus be pledged to the punctual payment of the principal and interest of said note at maturity.

On December 1st, 1940 the County of Columbus for value received, promises to pay to the BEARER hereof at the Chase National Bank of the City of New York, N. Y., the sum of Thirty Thousand (\$30,000.00) Dollars with interest at one and one-half (1 1/2%) percent per annum from date.

Be it ordered by the Board of County Commissioners of Columbus County that one note of the County of Columbus for General School purposes be executed in the sum of Fifteen Thousand (\$15,000.00) Dollars, dated July 15th, 1940, maturing October 15, 1940.

The above note bearing interest at the rate of one and three-fourths percent (1 3/4%) per annum, interest payable at maturity; both principal and interest of said note payable to BEARER at the Wachovia Bank and Trust Co of the City of Winston Salem, N. C. in anticipation of 1939 taxes, and that said note be sold or hypothecated and the proceeds thereof turned into the General Fund of said county of Columbus.

Be it further resolved that the full faith and credit of the County of Columbus be pledged to the punctual payment of the principal and interest of said note at maturity.
