Minutes of the last meeting being read approved, the following business was transacted.

The Board of Commissioners for the County of Columbus, North Carolina met in regular session at the Court House in Whiteville, the regular place of meeting, at 10 o'clock, A.M., October 7, 1940, the following members being present: W. L. Hobbs, Chairman, and Commissioners H. G. Avant, R. C. Benton, G. C. Hinson, C. A. Small.

Absent: None.

Commissioner H. G. Avant introduced the following bond order authorizing County bonds, which was read and is as follows:

### ORDER AUTHORIZING \$79,000

#### REFUNDING BONDS

BE IT ORDERED AND RESOLVED by the Board of Commissioners for the County of Columbus:

1. That bonds of Columbus County be issued pursuant to the County Finance Act, as amended, in an amount not exceeding \$70,000 for the purpose of refunding a like amount of the principal of valid subsisting bonded indebtedness of said County which was originally incurred before January 1, 1929 for the construction of roads and bridges in said County, and was legally created for necessary expenses of the County, and is evidenced by the following:

\$50,000 Road and Bridge Bonds, dated May 1, 1921 and maturing May 1, 1941. \$10,000 Road and Bridge Bonds, dated May 1, 1922 and maturing May 1, 1941. \$10,000 Road and Bridge Bonds, dated December 1, 1920 and maturing December 1, 1940.

- 2. That bonds of Columbus County be issued pursuant to the County Finance Act, as amended, in an amount not exceeding \$6,000 for the purpose of refunding a like amount of the principal of valid subsisting bonded indebtedness of the County which was incurred by the Board of Commissioners (as an administrative agent of the State in providing a State system of public schools) for the necessary expense of maintaining the constitutional six months' school term and is evidenced by \$6,000 School Funding Bonds, dated July 1, 1925 and maturing July 1, 1941.
- 3. That bonds of Columbus County be issued pursuant to the County Finance Act, as amended, in an amount not exceeding \$3,000 for the purpose of refunding a like amount of the principal of valid subsisting bonded indebtedness which was lawfully in curred in erecting and equipping school budidings necessary for maintaining the constitutional six months' school term and was thereafter assumed by Columbus County, which indebtedness is evidenced by the following:
  - \$2,000 Tatum Township School District School Bonds, dated January 1, 1924 and maturing January 1, 1941.
  - \$1,000 Chadbourn School District No. 3 School Bond, dated July 1, 1924 and maturing July 1, 1941.
- 4. That the holders of the \$79,000 refunding bonds herein authorized shall be subrogated to all the rights and powers of the holders of the indebtedness so refunded.
  - 5. That a tax sufficient to pay the principal and interest of said

\$79,000 refunding bonds shall be annually levied and collected.

- 6. That a statement of the debt of the County has been filed with the Clerk and is open to public inspection.
- 7. That this order shall take effect upon its passage and shall not be submitted to the voters.

## ORDER AUTHORIZING \$20,000 REFUNDING BONDS

BE IT ORDERED AND RESOLVED by the Board of Commissioners for the County of Columbus:

- 1. That bonds of Columbus County be issued pursuant to the County Finance Act, as amended, in an amount not exceeding \$20,000 for the purpose of refunding a like amount of the principal of valid subsisting bonded indebtedness of said County which was legally incurred for necessary expenses of the County and is evidenced by \$20,000 Funding Bonds, dated January 1, 1928 and maturing January 1, 1941.
- 2. That the holders of the \$20,000 refunding bonds herein authorized shall be subrogated to all the rights and powers of the holders of the indebtedness so refunded.
- 3. That a tax sufficient to pay the principal and interest of said \$20,000 refunding bonds shall be annually levied and collected.
- 4. That a statement of the debt of the County has been filed with the Clerk and is open to public inspection.
- 5. That this order shall take effect upon its passage and shall not be submitted to the voters.

The Board thereupom designated the County Accountant as mf the officer to file with the Clerk the statement of debt and assessed valuation required by the County Finance Act to be filed before the final passage of the bond orders this day introduced.

Thereupon the County Accountant filed with the Clerk, in the presence of the Board, the statement of debt and assessed valuation as required by Sections 13 and 14 of the County Finance Act.

The order authorizing \$79,000 refunding bonds was thereupon passed on first reading.

The order authorizing \$20,000 refunding bonds was thereupon passed on first reading.

And thereupon the Board fixed 10 o'clock, A.M., October 21, 1940 as the date and hour for the public hearing as required by Section 16 of the County Finance Act, and requested the Clerk to publish the bond orders, which has been introduced this day, together with the appended note as required by Section 16 of said Act, in the News Reporter not later than the tenth day before said date.

Ordered: That T. R. Gore 1929 to 1935 inclusive taxes in Bug Hill Township be separated so M. J. Suggs may pay tax on 29 acres which he purchased.

Ordered: That P. C. Collins be allowed to pay 1939 and prior years taxes due by paying 6% per annum and one-half court cost.

Ordered: That Wailous Wright's 1939, 1939 and 1940 taxes be separated so Hilton Spivey may pay taxes on 30 acres he has purchased.

Ordered: That Mrs. Artemisia S. DeVane be allowed to pay 1936 to 1939 inclusive taxes at 6% flat.

Ordered: That Red Cross be allowed to use Chapel and Hall leading to colored ward for use of Red Cross work.

Ordered: That N. Y. A. be allowed to use coffin house at County Home for a mattress factory.

Ordered: That ckeck for \$100.00 received from Dr. B. F. Huske, Guardian of Mrs. Elizabeth Bishop, be deposited to General County Fund for care of Mrs. Bishop at the County Home.

Ordered: That Jesse Simmons be allowed to pay 1933 to 1940 tax by paying 6% flat and no Court Cost.

Ordered: That Van Richardson's 1939 real estate taxes be separated from personal taxes so Fronis Strickland may pay tax as he owns the real estate. The Tax Collector is ordered to levy on personal property for tax.

Ordered: That Mrs. Retha Jackson 1937 through 1940 tax in Bug Hill Township be settled at \$300. valuation at 6% per annum.

Ordered: That F. T. Wooten be paid to premium on County Home Building Policy.

Ordered: That J. D. Maultsby 1926 and 1933 tax in Bolton Township be cancelled.

Ordered: That T. L. Gause taxes be separated so Ellen Hilburn may pay taxes on real estate she purchased.

Ordered: That T. J. Hall Heirs 1940 and prior years taxes due be separated so Colon Hall may pay tax on two acres valued at \$125.00 he owns.

Ordered: That George M. Mitchell be allowed to pay his 1928 to 1939 tax at 6% per annum and one-half Court Cost.

Ordered: That W. F. Cox be allowed to pay N. D. Murphy 1940 and prior years taxes due at 6% flat and one-half Court Cost.
