Ordered: that the County make a supplementary appropriation of \$150.00 to supplement this year's appropriation for Forest Fire Control, said sum to be advanced if and when funds are available.

Ordered: that \$1.00 per day be allowed for hospitalization in Southport for Forest Wilkerson's son for a period not to exceed six (6) months.

Obdered: that \$1.00 per day be allowed for hospitalization at State Sanatorium for Carrie and Alice Stabley, and that \$100.00 for bills previous to March 1, 1941 be allowed and paid on or after July 1, 1941.

Ordered: that the proceeds from the sale of whiskey in the amount of \$260.59 credited to the General County Fund on Feb. 5th, 1941, be transferred to the General School Fund.

On motion of Commissioner Bruce Pierce, seconded by Commissioner J. C. Stanley, it is ordered that the following resolution be and is adopted:

WHEREAS, this Board did, on March 24th, 1941, at the request of the Chairman meet as a Committee for the purpose of selecting a tax collector for Columbus County, made necessary by the recently appointed David N. Council's declining acceptance of said office, and that as said Committee, this Board did select and name B. L. Martin for said office at said time, all Commissioners being present and voting unanimously therefor.

THEREFORE, BE IT RESOLVED by this Board that we do confirm the selection and appointment of said Committee and do order that B. L. Martin be and he is appointed as Tax Collector for Columbus County and that said appointment is confirmed as effective as of March 24, 1941 and for a term of office beginning April 1, 1941 and expiring December 1, 1942.

Ordered: that B. L. Martin, newly appointed Tax Collector, for the faithful performance of the duties of his office as outlined by Statute and as directed by the Board of County Commissioners, shall receive as compensation a commission on all taxes collected by him, which have been delivered into his hands for collection, and that said commissions shall be based on each year's levy collected by him or that portion of said levy collected by him, and on the following percentages:

First: One Percent (1%) up to \$50,000.00

Second: Two percent (2%) from \$50,000.00 up to \$150,000.00

Third: Three percent (3%) from \$150,000.00 up to 80% of said levy

Fourth: Five percent (5%) on all collections over 80% of said levy

Fifth: That the above rate of commission shall be applied to each respective year's collections of each respective year's levy delivered into his charge for collection, and that the particular rate of earned commissions for the respective levies shall be determined by the amount of the levy as shown by the abstract less

the amount collected at the time it is delivered to the Tax Collector, and that said Tax Collector shall be paid from the General County Fund the first of each month for the prior month's accumulated commissions; that the Tax Collector shall be allowed a drawing account of \$200.00 monthly to be used when needed as approved by the Board of Commissioners, and that said drawing account when used, shall be charged against said commissions; that the Tax Collector shall be and is empowered with the authority to employ and discharge, subject to the approval of the Board of Commissioners, any office and clerical assistance or deputy tax collectors, said help or deputies to be employed at the expense of the Tax Collector; that the incindentals such as necessary office supplies, postage, stationery and advertising, shall be expenses paid by the County.
