Greetings and welcome were extended by the Board to the newly appointed Commissioner, J. A. Hooks.

Ordered: that J. O. Minter, Fair Bluff Township, be allowed to pay 1936 taxes due on real estate at value it was listed for in 1937, if settled by October 6, 1941.

Ordered: that 1941 assessors be advanced one-half of the amount due them by the county, less all taxes due the county by them; and, that on 1940 taxes due, no penalty be added after May 1, 1941.

Ordered: that Fourteen Hundred Dollars (\$1,400.00) of 1941 tax prepayments be transferred from the General County Fund to Columbus County Vocational Education Fund, so that the August salaries may be released.

Ordered: that 13¹/₂ acres, Cox and Carroll tract valued at \$325.00, and 20 acres, Streety Carroll tract valued at \$920.00, listed by W. A. Thompson, Lees 1941 Township, be segregated so that he may pay/taxes thereon.

Ordered: that settlement for taxes due Columbus County on property owned or controlled by J. C. and J. R. Williamson, Charles H. Phillips, Carolina Strawberry Farms and Columbian Land Co. be allowed by payment at par plus 6% and 1/2 court cost, provided all taxes due are paid and paid by October 6, 1941.
