As prescribed by law, the Board was declared as sitting as a Board of Equalization and Review.

The following business was transacted.

On motion, Mr. J. L. Robinson was made Chairman Pro Tem, pending the arrival of the Chairman, Mr. A. W. Williamson.

Ordered: that Richard E. Stone, Waccamaw Township, be issued General County Fund check for \$3.00 to refund him for \$3.00 paid on dogs listed to him through error.

Ordered: that Mrs. Addie Hinson Heirs be issued General County Fund check for \$7.17 to refund her on \$535 valuation listed through error in 1935.

Ordered: that J. C. Cribb be and he is hereby appointed as Constable for Williams Township.

Ordered: that one 16 acre tract in Bogue Township valued at \$1520 and listed by J. Reston Powell for 1942 be cut out and the tax collector be refunded therefor.

Ordered: that the tax collector be refunded on J. H. Hinyard, Ransom Township, on \$405 valuation on 8 acre Rebecca Flowers tract for year 1941 and \$305 valuation for year 1942.
