Ordered: tha contract be let for \$850.00 to Perfection Co. for  
a guaranteed termite control for five years at courthouse annex.

Ordered: that J. T. Wooten, Jr., Chadbourn Township, be allowed  
exemption of late listing penalty for 1955 listing.

Ordered: that Roscoe Coleman, Tatum Township, be allowed exemption  
of late listing penalty for 1955 listing.

Ordered: that Mrs. Cornelius Coleman, Tatum Township, be allowed  
exemption for late listing penalty for 1955 listing.

Ordered: that the taxes of Rena Freeman in Bolton Township for  
years 1947 through 1954 be settled upon the payment of the tax on \$2500 real estate  
valuation plus the tax on all personal property listed as the value over \$2500 is an  
error of the tax lister.

Ordered: that D. M. Stanley 1937 tax in Williams Township be paid  
at par and no cost allowed.

Ordered: that the 1932 tax of Dwight M. Stanley, South Williams  
Township, be cancelled and tax collector given a release as this has been listed  
in error.

Ordered: that the tax listed to John W. Brown in Tatum Township for
