Ordered: That the County Accountant be authorized to buy savings bonds with the \$2,000.00 received by cashing bonds in the Chadbourn Drainage Fund. These bonds had reached maturity.

Ordered: That a postage meter be purchased for use of all county offices in the courthouse. Cost \$300.70.

Ordered: That the County farm be leased to A. B. Dawsey for a period of five years. Rent to be \$1,200.00 per year to be paid yearly by the 15th of each September. If at any time during the five years any part of the land is needed by the county for other purposes said rent shall be adjusted accordingly.

Ordered: That all vital statistics registration for the entire county be handled through the Health Department and that Dr. Floyd Johnson be appointed registrar for Columbus County.

Ordered: That taxes listed in the name of J. T. Pope, Waccamaw Township, for 1949, 1950 and 1951 be cancelled as this was listed through error

Ordered: That taxes listed in the name of William Edward Pope, Waccamaw Township, for the years 1952 through 1956 be cancelled, due to error in listing.

Ordered: That Mrs R. C. Applewhite be allowed to pay taxes listed in the name of R. E. Applewhite for the years 1935, 1936, 1937, and 1942 at par. Ransom Township.
