The following business was transacted:

Ordered: that a check in the amount of \$15.00 be given to Edna George from the Out Door Poor fund.

Ordered: that Commissioner W. B. Buffkin be re-appointed to the County Welfare Board.

A motion was made and carried to rescind an order of the June 4th meeting regarding the Social Security budget for the 1962-63 fiscal year, and the budget was approved as presented on that date.

County Superintendent of Schools, T. Ward Guy, presented the schools' budget for the 1962-63 fiscal year and it was approved as submitted.

Ordered: that the budget estimate as submitted to the Board by Mazzalee T. Sanderford, County Accountant, be tentatively approved. It was further ordered that a copy of the estimate be filed with the Clerk to the Board for public inspection, and that a copy of same be made available to the newspapers of the county. As required by law, it was ordered that a notice be run in the newspaper once to the effect that the budget estimate is on file in the office of the Clerk to the Board of Commissioners.

Chairman L. P. Ward introduced the following resolution:

RESOLUTION RELATING TO THE CANVASSING OF THE RETURNS OF THE SPECIAL BOND ELECTION HELD IN THE RIEGELWOOD SANITARY DISTRICT ON JUNE 5, 1962.

BE IT RESOLVED by the Board of Commissioners for the County of Columbus:

Section 1. The returns of the special bond election held on June 5, 1962, in the Riegelwood Sanitary District, Columbus County, having been received from the proper election officers and the Board having canvassed the same, the following facts are hereby found and determined:

(a) That at a special bond election held in the Riegelwood Sanitary District on June §, 1962, there were submitted to the qualified registered voters of said Riegelwood Sanitary District the following two propositions:

- 1. Issuing not exceeding \$110,000 General Obligation Water Bonds for the purpose of providing funds for the acquisition and extension of a water system for the District, as authorized by a bond resolution adopted by the Sanitary District Board of said District on April 19, 1962, and the levy of a tax for the payment thereof.
- 2. Issuing not exceeding \$10,000 General Obligation Fire Fighting Equipment and Apparatus Bonds for the purpose of providing funds for the purchase of fire fighting equipment and apparatus for the District, as authorized by a bond resolution adopted by the Sanitary District Board of Said District on April 19, 1962, and the levy of a tax for the payment thereof.

(b) That the Board believes that said election was conducted in full compliance with law.

(c) That the following schedule correctly shows the designation of the polling place at which the election was held, the number of voters registered and qualified to vote in the election, the number of votes cast in favor of each proposition submitted and the number cast against each proposition:


Section 2. At said election a majority of the qualified registered voters of the Riegelwood Sanitary District who voted thereon at said election voted for the approval of the bond resolution adopted by the Sanitary District Board of the Riegelwood Sanitary District on April 19, 1962, authorizing the issuing of not exceeding \$110,000 General Obligation Water Bonds of said Sanitary District for the purpose of providing funds for the acquisition and extension of a water system for the Riegelwood Sanitary District, and the levy of a tax for the payment thereof.

Section 3. At said election a majority of the qualified registered voters of the Riegelwood Sanitary District who voted thereon at said election voted for the approval of the bond resolution adopted by the Sanitary District Board of the Riegelwood Sanitary District on April 19, 1962, authorizing the issuing of not exceeding \$10,000 General Obligation Fire Fighting Equipment and Apparatus Bonds of said Sanitary District for the purpose of providing funds for the purchase of fire fighting equipment and apparatus for the Riegelwood Sanitary District, and the levy of a tax for the payment thereof.

Section 4. The Elerk of the Board of Commissioners be and he is hereby directed to transmit a certified copy of this resolution to the Sanitary District Board of the Riegelwood Sanitary District.
