

The Commissioners and other County Officials assembled in the Commissioners Office, December 3, 1962 at 12:00 Noon.

Lee J. Greer, re-elected Clerk of Superior Court was duly sworn in by Chairman L. P. Ward after which the following re-elected officials were sworn in by Mr. Greer:

L. P. Ward was nominated and duly elected to serve as Chairman of the Board for 1963.

W. B. Buffkin was nominated and duly elected to serve as Vice Chairman of the Board for 1963.

Ordered: that all county employees who are presently employed be re-appointed for the year 1963, and that the surety bonds of the various employees be approved as recorded in the office of the Register of Deeds and the Clerk of Court.

It was brought to the attention of the Board that there had been some misunderstanding as to the classification of two county employees; namely, W. A. Weir and Mrs. Venie Rouse. Upon motion made and duly seconded, W. A. Weir was appointed County Tax Supervisor and County Tax Collector, and Mrs. Venie Rouse was appointed Assistant Tax Supervisor.

Ordered: that the county offices be closed for the Christmas holidays Monday through Wednesday, December 24th, 25th, and 26th.

Ordered: that the Chairman and Clerk be authorized to release the December salary checks of county employees on December 22nd.

Ordered: that Robert W. Swain be employed as an Assistant County Agent effective January 1, 1963, to fill the vacancy created by the resignation of C. M. Garris.

Ordered: that John Paul Millican of Bolton, N. C., and Francis Winnies of Rt. 2, Box 3, Chadbourn, N. C. be recommended to the District Forester to fill the vacancy which occurs in the position of County Forest Ranger.

Ordered: that the county attorney be authorized to meet with the Town of Whiteville attorney to work out a solution to the parking problem on the courthouse square.

Ordered: that the Tax Collector be authorized to have a criminal warrant issued against Henry Lee Troy for non-tax listing in 1962, and against Earl D. Sikes of Acme, N. C. for the same offense in 1962.

Ordered: that the Tax Collector be authorized to garnishee the wages of Grady Rich, Whiteville Township, for past due taxes-- 1960 and 1961.

The specifications and contract documents covering appraisal of property, tax assessor's manual, and property record cards for Columbus County was approved as presented by the county attorney and he was authorized and instructed to proceed immediately with the notices to bidders.
