of Columbus County will receive the sum of \$1,291,025.78 for use in building additional school buildings when they are needed; and if these State School Bonds are not approved, the taxpayers of Columbus County will have to raise this amount from property taxes; and

WHEREAS, this amount and more will be necessary in the immediate future if the children of Columbus Countypare to have adequate buildings in which to study and prepare for a productive role in the life of their community, the county, and the State;

NOW THEREFORE BE IT RESOLVED by the BOARD OF COUNTY COMMISSIONERS of Columbus COUNTY that the State School Bonds be and they hereby are heartily endorsed, because they will help provide the additional school buildings that our children need.

AND BE IT FURTHER RESOLVED that all the voters of Columbus County be and they are hereby urged to vote FOR the issuance of these State School Bonds at the General Election on November 3.
