The following business was transacted:

A motion was made, duly seconded, and unanimously passed to retain Sankey W. Robinson as county attorney.

Chairman H. J. Watts was called home due to his wife's illness and Commissioner W. O. Johnson, vice-chairman, presided for the remainder of the meeting in his absence.

Ordered: that the action taken terminating the Columbus County Civil Defense Program as of March 1, 1965 be rescinded and that the County Civil Defense Program be continued.

Ordered: that all county employees working on a daily basis be paid a salary of \$225.00 per month effective February 1, 1965.

Ordered: that J. Hubert Norris be employed as chief clerk to Mrs. Venie H. Rouse, Assistant Tax Supervisor, effective February 22, 1965 at a salary of \$250.00 per month.

Ordered: that Mrs. Woodrow (Doris) Ward of Evergreen be employed as an assistant in the office of the tax collector effective February 22, 1965 at a salary of \$225.00 per month.

Ordered: that the order to terminate the services of Civil Defense Director L. R. Wayne as of March 1, 1965 be rescinded, and that he continue as Civil Defense Director of Columbus County under the direction of the County Board of Commissioners.

Ordered: that the county attorney be authorized and instructed to proceed with the sale of \$500,000 bonds for the community college.

Ordered: that the Southeastern Community College be authorized to amend its budget to transfer certain current expense funds to capital outlay within their overall budget.

The following resolution was unanimously adopted:
