The following business was transacted:

S. J. Shaw of S. Preston Douglas & Associates, Lumberton, N. C. presented the audit report of all funds and accounts of the Clerk of Superior Court for the year beginning December 1, 1964 and ending November 30, 1965. It was ordered that this report be accepted as presented, and that their contract be extended for the year 1966 on the same basis as the present— at a rate of \$40 per day plus reasonable travel and subsistence expense for the services of each accountant engaged in the work.

Ordered: that upon presentation of a properly executed surety bond, Erusie Gaskins be appointed to serve as Constable in South Williams Township until such time as he is sworn into the elective position.

Ordered: that taxes listed in the name of F. L. Walker, Chadbourn Township, be accepted at par for the years 1930 through 1952.

The Board of Commissioners finds as a fact that one lot, listed in the name of C. M. Cox, South Williams Township, was listed to him in error for the years 1960 through 1964, and that during said years taxes totaling \$37.44 were paid by the said C. M. Cox to Columbus County, and that he is entitled to a refund of said amount erroneously paid. It is therefore ordered that said sum be refunded to said C. M. Cox.

Ordered: that personal taxes listed in the name of Martin Cribb, Williams Township, be accepted at par for the year 1954.

Ordered: that taxes listed in the name of James Graham, Waccamaw Township, be cancelled for the year 1964 due to double listing as found by Southern Appraisal Company.

Ordered: that taxes listed in the name of Y. N. Gore Heirs, Lees Township, be accepted at par for the years 1938 through 1952.

The budget estimate for the fiscal year 1966-1967, with revisions as directed by the Board, was submitted by Mazzalee T. Sanderford, County Accountant, and it was ordered that it be tentatively approved with a tax rate of \$1.59 per \$100 valuation.
