The following business was transacted:

Ordered: that an estimated \$639.00 be appropriated to install a sprinkler system and to beautify the courthouse grounds as proposed by the Beautification Committee of Whiteville and presented to the Board by Mrs. Anne N. Talbott upon the request of the Board of Commissioners .

James C. Cox, Executive Director of SENCLand Community Action, Inc. appeared before the Board to review the work done by this organization and to familiarize the Board with the program, its aims and proposed projects for the ensuing year. It was ordered that the Board of County Commissioners, after reviewing the SENCLand Community Action proposals, certify and approve the use of available public county buildings and property which are not presently being used by other agencies, as Columbus County's source of non-federal share of the Community Action budget.

ROAD PETITION: South Williams Township: Road turns South off H.Way 701 By-Pass between Radio Station WTAB and Yam City Oil Co. .7 mile in length and there are nine occupied homes located on it.

WHEREAS Delphia Norris has heretofore executed a lien to the County of Columbus to secure the county for payments by the welfare department to her, and

WHEREAS said lien is recorded in the office of the Clerk of Superior Court in OAA Lien Book I on page 176 and being lien No. 1353, and

WHEREAS certain property hereinafter described in which said Delphia Norris owns an undivided interest has a fair market value of \$13,000, and

WHEREAS the share of said Delphia Norris in said property has a fair market value of \$1,323.46, and

WHEREAS said Delphia Norris has requested that said property hereinafter described be released from the OAA lien as recorded in the OAA Lien Book I, page 176, lien No. 1353, upon the payment to the County of Columbus the sum of \$1,323.46 which sum represents the fair market value of the interest of said Delphia Norris in and to said property, and

WHEREAS the Board of County Commissioners finds as a fact that said \$1,323.46 represents the fair market value of the interest of Delphia Norris in and to said property, it is therefore moved and ordered that upon the receipt of said \$1,323.46 the receipt of which is hereby acknowledged, the said property hereinafter described shall be and forever hereafter released and discharged from said OAA lien as recorded in Book I, page 176, lien No. 1353.

The said property being referred to being described as follows:

TRACT #1: Beginning on a stake known as S. W. Norris big corner and runs North $8\frac{1}{2}$ East 4 chains and 75 links to a stake; thence North 33 East 21 links to a stake at a ditch; thence with ditch North $39\frac{1}{2}$ West 25 chains and 61 links to a stake, V.T. Norris corner in N. W. Smith's line; thence South 32 West 14 chains and 75 links to a stake in a bay; thence South $6\frac{1}{4}$ East 27 chains to the beginning, containing Twenty Five acres, more or less.

Except so much of the lands heretofore sold by Cora D. Garrell Harrelson and husband, to J. Q. Piver and wife, as recorded in Book 171, page 383, Columbus County Registry.



Ordered: that all county personnel be re-appointed for the year 1967, and that surety bonds of various employees be approved as recorded in the office of the Register of Deeds and the Clerk of Court.

Ordered: that all county offices be closed December 23rd through December 27th for Christmas Holidays and that work be resumed on Wednesday, December 28th.

Ordered: that the chairman and clerk be authorized to release the December salary checks of county employees on December 20, 1966.

Ordered: that the resignation of Dorothy Valentine, Home Economics Extension Agent on leave, be accepted.

Beasley Strickland, Chairman of Gapway Drainage Commission, requested a loan of \$4,000 from the county for the purpose of meeting a payment due the Production Credit Association prior to tax collections by the Drainage Commission.
