Upon motion made by Com. Watts, seconded by Com. Gore, the following resolution was unanimously adopted:

WHEREAS, nutgrass or nutsedge has become the number one weed pest in Columbus County and is causing a great deal of concern among the farmers throughout the county, and

WHEREAS, nutgrass or nutsedge is rapidly spreading throughout the county and in some cases to the point that it is almost impossible to grow a crop, and

WHEREAS, with machinery and mechanization it is almost impossible to hold nutgrass down without an extreme amount of hoe labor that is not available,

THEREFORE BE IT RESOLVED that we the Board of County Commissioners of Columbus County respectfully request the Agricultural Research Service and others to help find ways and means of controlling nutgrass to the point that tobacco and other row crops can be profitably grown on fields infested with nutgrass. We feel that additional research work should be done by the research department in trying to find some chemical or herbicide that would help eradicate nutgrass and at the same time not be injurious to the production of tobacco and other crops.
