A copy of the Columbus County Hospital Audit Report was reviewed and the hospital staff and Board of Trustees were commended for this excellent report and for the fine work which they are doing.

Ordered: that the valuation of real property listed in the name of Fannie Suggs Walton, Bug Hill Township, be reduced in the amount of \$2,010.00 for the year 1966, and that
