

The Honorable Board of County Commissioners met in their said office at 10 a.m., February 6, 1967 it being first Monday.

The following business was transacted:

Ordered: that Stanley D. Wilson and R. M. Hobbs be appointed to the Riegelwood Sanitary District Board of Commissioners to fill the vacancies which exist due to the resignation of Commissioners A. L. Walters and R. O. Brandt.

Richard P. Mauney, Executive Secretary of the Economic Development Commission, appeared before the Board to request permission to transfer funds with which to pay the salary of a substitute stenographer in the absence of Mrs. Doris S. Hughes, regular stenographer on sick leave. The request was not granted due to the fact that the Board felt it was not in keeping with prior sick leave practices.

Ordered: that Com. Edward W. Williamson be appointed to serve on the Board of Directors of SENCLand Community Action Agency, Inc. for a period of one year.

Jack Hooks, attorney for the Whiteville City Schools and C. W. Duggins, superintendent, appeared before the Board to file a petition for a local election to impose a separate local supplement tax for the use of Whiteville City Schools. It was ordered that the petition of the Whiteville Board of Education requesting an election to determine a local supplement tax be approved and that the date for said election be fixed for April 11, 1967. The county attorney was instructed to proceed with any necessary action to accomplish this election. (For other action taken this date, see supplemental minutes on page 683.)

Ordered: that a county-owned building located beside the welfare office be transferred to the Whiteville Committee of Fine Arts and Museum in consideration of their offer to restore the building and place it on a prominent and suitable site in the Town of Whiteville and that said renovated building shall be equipped with suitable plaques and other documents attesting to its origin and historical significance and shall be used as an historical site and open for visits by the general public. The Board of Commissioners finds as a fact that this represents good, full, and valuable consideration for said building. It was further ordered that the chairman and clerk be authorized to sign a conveyance of said property.

Dr. J. R. Black, Health Director, appeared before the Board along with Horace Whitley, Chairman of the Welfare Board, to request that the retirement system be adopted and approved for the Health Department's employees beginning July 1, 1967. There was a general discussion and this request was tabled until a later meeting.

Lacy R. Thompson and George Turner of Chadbourn requested that the Chadbourn Community Pool, Inc. be exempt from taxation. The Board reacted favorably to this request and a decision will be made at a later meeting.

A. N. Bozeman of Tyson & Van Advertising again reviewed his proposal for identification signs on the Courthouse and County Hall. It was ordered that said company proceed with the installation of said signs and the chairman was authorized to sign a contract for this work, and \$997.92 be appropriated out of surplus to cover this expense.
