A RESOLUTION CREATING JOINTLY WITH OTHER COUNTIES AN ECONOMIC DEVELOPMENT COMMISSION

WHEREAS, while the Coastal Plains Region of the State of North Carolina is abundant in natural resources and rich in potential, its people lag behind certain other regions of the State of North Carolina and the Nation and have not shared properly in the Nation's prosperity; and

WHEREAS, the people of the region understand their problems and have worked and will continue to work purposefully toward the solution of their economic problems;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF COLUMBUS County in conjunction with Boards of County Commissioners in other counties presently proposed and/or subsequently determined as comprising an Economic Development District THAT there is hereby created a regional Economic Development Commission, the purpose of which is to assist the region in meeting its special problems, to promote economic development, and to establish a framework for joint Federal and State efforts toward providing the basic facilities essential to its growth and attacking its common problems and meeting its common needs on a coordinated and concerted basis;

RESOLVED FURTHER that the membership of the Economic Development Commission shall be appointed as follows: Three members shall be appointed by each of the several Boards of County Commissioners. The original three members appointed by each Board of County Commissioners shall serve terms of one year, two years, and three years respectively. All subsequent appointments shall be for three years. It shall be permissible for the Board of County Commissioners to reappoint present members to succeed themselves.

RESOLVED FURTHER that compensation for the members shall be established by the Rules and Regulations if the Economic Development Commission which shall hereafter be promulgated;

RESOLVED FURTHER that the formula for financial support shall be determined on the basis of population, computed with respect to the latest decennial census, and shall be set forth specifically in the Rules and Regulations of the Economic Development Commission which shall hereafter be promulgated;

RESOLVED FURTHER that this Economic Development Commission is created pursuant to Article 2 of Chapter 158 of the North Carolina General Statutes.

Upon motion of Comm. T. E. Burns, seconded by Comm. H. J. Watts, the following resolution was unanimously adopted:

WHEREAS, The Whiteville City Board of Education has submitted to this Board a Petition, pursuant to the provisions of Chapter 115, Article 14 of the General Statutes of North Carolina, requesting the Board of Commissioners of the County of Columbus to call an election in the area comprising the Whiteville City School

Administrative Unit, which area is described in said Petition as follows:

BEGINNING at a point in the County line between Columbus and Bladen Counties, said point being about one mile Eastwardly from Highway 410 and on the Western boundary of the farm belonging to Arthur Collier, and runs thence a direct line in a Southerly direction about 1.8 miles to the head of a branch at a point about one mile East of Highway 410 and one miles North of the road leading from Highway 410 to Wooten's Store; thence down the run of said branch to its junction with West Prong Creek; then up West Prong Creek to its fork about 3/10 miles South of the road leading from Highway 701 to Highway 410; thence up the East fork of West Prong Creek to its head; thence a direct line in a Southeasterly direction to the head of the West fork of Gray Branch; thence down the West fork of Gray Branch to its junction with the East fork of said branch; thence a direct line in a Southerly direction to the intersection of a road with Highway 74-76, said road intersection being 2.1 miles Eastwardly from the intersection of Peacock Road and Highway 74-76; thence a direct line in a Southwesterly direction to the head of the Northeast fork of Cedar Branch; thence down Cedar Branch to the junction of the North and South forks of said branch; thence up the run of the South fork of Cedar Branch to its junction with Five Mile Branch; thence up Five Mile Branch to its fork about 4/10 miles North of the road leading from Wards to Highway 701; thence a direct line in a Southerly direction to the forks of Beaver Dam Swamp about 1.8 miles Westwardly from Highway 701; thence down Beaver Dam Swamp to Highway 701; thence a direct line in an Eastwardly direction to Highway 130 at Pleasant Plain Church; thence a direct line about North 30 degrees East to White Marsh; thence up White Marsh to Red Hill Swamp; thence up Red Hill Swamp to the Bladen County line; thence with Bladen County line Westward to the beginning. The same description is the one made by E. M. Eutsler, Registered Engineer, on January 5, 1946, and the correction as made by him on February 7, 1947.

- 2. That there shall be a new registration of the qualified voters of those residing in the area of the Whiteville City School Administrative Unit as above described;
