Ordered: that the County Attorney be authorized to write Mr. Carl W. Meares, State Highway Commissioner, and request that appropriate traffic signals be installed or other measures taken in order to promote safety and the flow of traffic at the various intersections surrounding the Columbus County Courthouse.

It is recommended that the County Attorney call to the attention of Commissioner Meares that personal injury and property damage has occurred recently because of the congested traffic conditions and to express the concern of this Board regarding same.
