The auditor presented the 1970-1971 budget estimate to the Board of Commissioners with an overall tax levy of \$1.70. Commissioner Williamson stated he was in favor of a 5¢ increase for schools; meet Mental Health requests and also adjustments of salaries for the sheriff's dept. and Register of Deeds office.

beginning with the fiscal year July 1, 1970, and that the fiscal year beginning July 1, 1971 the levy shall not exceed 20¢. Further that the special 20¢ levy be deleted from the tax levy for the fiscal year 1972-1973. The following vote was taken by the Chairman:
