RESOLUTION REQUESTING A REDUCED SPEED LIMIT IN WEST COLUMBUS SCHOOL AREA

WHEREAS, the Board of County Commissioners of Columbus County is vitally interested in the public health safety and general welfare of the schools children in Columbus Rex

County; and

WHEREAS, it has come to the attention of the Board of County Commissioners that there exists a dangerous traffic hazard in the vicinity if the West Columbus High School and Elementary School, both of which are located in the Cerro Gordo Community of Columbus County; and

WHEREAS, Highway 76 is a main highway traveling by said school; and WHEREAS, the posted speed limit at present is 55 miles per hour; and

WHEREAS, this Board desires that the State Highway Commission investigate said traffic situation; and

WHEREAS, this Board recommends that posted speed limit along said school area be reduced to 35 miles per hour;

IT IS NOW, THEREFORE, RESOLVED that a copy of this resolution be sent to the State Highway Commission in Raleigh, North Carolina, requesting that an investigation be made and that the speed limit along said highway in the area of said school be reduced to 35 miles per hour.

IT IS FURTHER ordered that a copy of this resolution be sent to the members of the General Assembley representing Columbus County and that they are hereby requested for assistance in getting the purpose of this resolution accomplished.
