Ordered: That H. J. Watts be authorized to rent the county farm for the 1972 season.

Ordered: that Mr. Charles Ward be hired as Soil Scientist to work for Columbus County. Funds are to be furnished by the Emergency Employment Act in the amount of \$7,200.00.

BE IT RESOLVED by the Board of Commissioners that they request and approve the following addition to the State System of highways: Beginning at a point .5 mile north of U. S. 74-76 westward .1 mile to a dead end which is an extension of S.R.1734 in Bogue Township.
