The Board of Education, with all members present, Supt. Hicks and Attorney E. L. Williamson met with the Board to impress upon the Commissioners the needs of the schools of Columbus County. Slides were shown of the deteriorating condition of several buildings and lengthly comments made by Supt. Hicks. Attorney Williamson stated that the needs of the schools as set out in the Budget request were a very minimum which is a statutory requirement.
