

The Honorable Board of County Commissioners met in their said office at 10:00 a.m., July 17, 1972, it being third Monday.

The meeting was called to order and the following business was transacted:

Ordered: that Mr. Raper be allowed to spend funds in the miscellaneous account of the Extension Service Budget to cover extension secretaries with disability benefits until the Federal Government assumes this expense when each person has been employed for a period of five years. This amount is \$216.00.

Ordered: that each person included in the budget to receive \$200.00 for uniforms be given a check by the Accountant instead of paying bills through the Accountant's Office.

This order was passed by a vote of 3 to 2, with Commissioners Watts, Gore, and Williamson voting YES; Commissioners Johnson and Burns voting NO.

Ordered: that the Courtroom Officer be included to receive \$200.00 for uniforms in the Sheriff's Dept. Budget for 1972-73.

A motion was made by Commissioner Watts to approve the revised budget for the Sheriff's Dept.; a further motion was made to table this motion until the next meeting and was seconded by Commissioner Gore.

Ordered: that Deputies who had not spent the full amount of their uniform allowance for 1971-72 be given a check for the balance and all bills that are due on uniforms be paid.

Ordered: that due to a misunderstanding, Mr. Griffin recommends that the taxes listed in the name of Mrs. William A. Love, Waccamaw Township, be accepted at par for the year 1970.

Upon motion of Commissioner Johnson, seconded by Commissioner Burns, and un-animously passed the attached uniform schedules of values, standards, and rules to be used in appraising real property in the county were adopted by the following resolution:

BE IT RESOLVED that the schedule as presented by Carroll-Phelps Co., a copy of which is hereto attached, is hereby approved and adopted by the Board of Columbus County Commissioners and it is ordered that a copy of this order be published in form of a notice in the News Reporter stating the schedule to be used in next scheduled reappraisal of real property have been adopted and are open for examination by any property owner in the county in the office of the Tax Supervisor for ten days from the date of publication of this notice as required by G.S.105-317 (B) (1).

Mr. Lawrence Long who sells mobile homes in Columbus County came to voice a complaint against Mr. McArthur, Electrical Inspector, concerning disagreements in the business transactions of Mr. Long in which Mr. McArthur allegedly interfered. The Board is to talk with Mr. McArthur about this matter in the near future.

Upon motion the meeting adjourned until Monday, July 24, at 8:00 p.m. to continue unfinished business, namely Sheriff's Budget.
