The meeting was called to order and the following business was transacted Ordered: that the Audit Report for the fiscal year 1971-72 be accepted as presented by Mr.Carl Wilkins, CPA from S. Preston Douglas & Associates, Lumberton, N. C.

Mr. Wilkins presented a contract for the Board's consideration for the year 1972-73. No action was taken on the contract at this time.

Ordered: that the Board of Education be allowed to make adjustments within their Budget, i.e. change funds from one code number to another and the necessary papers be signed by the Vice-Chairman.

Ordered: that Mr. Griffin be allowed to hire a replacement for Izear Dunson, Asst. Janitor at the Courthouse.

Representatives from Whiteville, Tabbr City, and Acme-Delco Rescue Squads were present to discuss further the needs of the Rescue Squads and reinstating their request for county funds to support the Squads. Upon motion of Commissioner Watts, seconded by

Commissioner Gore, the three Squads present are to receive \$1,000 for each accepted vehicle

(Certified Ambulances and Emergency Vehicles) which is four vehicles each, a total of twelve

vehicles. The total money is \$12,000.00 to be appropriated out of Surplus.

Ordered: that an Emergency Planning Board be created to study and make recommendations

on the emergency operations in Columbus County.

RESOLUTION CALLING SPECIAL ELECTION FOR ACME-DELCO FIRE DISTRECT

WHEREAS, a petition has been duly presented to the Columbus County Board of Commissioners by at least fifteen per cent of the resident freeholders living and residing in the area lying outside the corporate limits of any municipality in Columbus County, N. C., which area is described in said petition and described in said petition and designated as "Acme-Delco Fire District";

WHEREAS, under the provisions of General Statutes 69-25.1 et seq., the Board of Commissioners of Columbus County are directed to call an election upon the question of leveying a special tax in said Acme-Delco Fire District as hereinafter provided, for the purpose of providing fire protection in said fire district;

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of Columbus County as follows:

SECTION L. That a special election shall be held in the territory and fire district hereinafter described on the day of the General Election, Tuesday, November 7, 1972, for the purpose of submitting to the qualified voters residing in said fire district in Columbus County, the issue as to whether or not there shall be levied and collected in said fire district annually a special tax not to exceed fifteen (15ϕ) on the One HUndred (\$100.00) Dollars valuation on all taxable property, real and personal, in said area or district for the purpose of providing fire protection in said district.

SECTION II. That the Acme-Delco Fire District includes that certain areatin Ransom Township, in Columbus County, according to a map filed with the Clerk of the Board of Commissioners of Columbus County, said fire district lying and being putside all municipalities in Columbus County, and which is more particularly described by metes and bounds as follows:

BEGINNING at a point (1) on U. S. Hwy. 87 North, at its intersection with U. S. Hwy. 141; thence in a southerly direction to a point (2) on W. M. Waddell Road (#1812), at its intesection with Pearl Sutton Road (#1813); and excluding all property on W. M.
