The meeting was called to order and the invocation was given by the Reverend Cleatus J. Blackmon, Jr., Pastor, White Marsh Baptist Church.

The following business was transacted:

Ordered: that the forms assuring Columbus County will abide by the requirements of the State & Local Fiscal Assistance Act of 1972 in regards to spending Revenue Sharing Funds be signed by the Chairman.

Ordered: that the necessary forms be signed by the Chairman to apply for a federal grant through the Lower Cape Fear Planning Unit for funds to install a new communications system in Columbus County for Law Enforcement personnel.

Ordered: that all radio equipment now owned by the County that cannot be used in the new communications system be given to the Fire & Rescue Squads upon the approval of the Lower Cape Fear Planning Unit, to which we have applied for federal assistance in implementing the new communications system. A copy of the minutes of the meeting containing the agreements of the Fire & Rescue Squads is to be on file with the Clerk to the Board.

Ordered: that a new contract be made when necessary to cover the maintenance of the base station and repeater system by the County for the Fire & Rescue Squads in the County.

Ordered: that upon the completion of the necessary requirements of Special Sessions Law Chapter 72, the following persons be approved as Special Deputies for Southeastern Community College: Solomon A. Pridgen, Sampson McCormick and Otis H. Lennon.

The following resolution was unanimously passed, upon motion made by Commissioner Brown, seconded by Commissioner Buffkin:

BE IT RESOLVED that the Board of County Commissioners of Columbus County desires to receive mental health services from present historical, natural grouping of medical service referral which is Southeastern Regional Mental Health Center. We desire to continue our participation through the FY 1973-74 and will decide at that time if we wish to continue further.

Ordered: that the Supplemental Capital Outlay Budget for Southeastern Community College be approved as presented by Mr. Stanley, Manager, and additional funds as approved at an earlier meeting be advanced from the General Fund in the amount of \$28,000.00.

Ordered: that upon the recommendation of the Tax Supervisor, the following releases be made:

that the 1972 taxes listed in the name of Lee & Ida Oglsby, Ransom Township, be cancelled in the amount of \$4.08 due to an error in listing.

that the 1972 taxes listed in the name of Westport Industries, Inc., South Williams Township be cancelled in the amount of \$168.73 due to error in listing.

that the taxes listed in the name of Golden Boone, Jr., Bogue Township, be cancelled. in the amount of 42.36 due to double listing.

The following lease agreement was entered into upon motion made by Commissioner Burns, seconded by Commissioner Buffkin and unanimously adopted:

STATE OF NORTH CAROLINA, COUNTY OF COLUMBUS

**LEASE** 

THIS LEASE, made and entered into this <u>5</u> day of <u>March</u>, 1973, by and between COLUMBUS COUNTY, a political subdivision of the State of North Carolina, and ED WALTON WILLIAMSON, W.B. BUFFKIN, T. EDISON BURNS, MAYO BROWN and DONALD P. CURRIE, individual members constituting and comprising the Board of Commissioners of Columbus County, North Carolina, parties of the first part, and hereinafter referred to as "LESSORS," and the Trustees of the Columbus County Hospital, Inc., a public, charitable, non-profit hospital corporation, organized under and existing pursuant to the laws of the State of North Carolina, party of the second part, and hereinafter referred to as "LESSEE":

WITNESSETH: That for and in consideration of the covenants and agreements hereinafter set forth, Lessors have demised and leased, and Lessee accepts as tenant of Lessors, all of that certain tract or parcel of land located in Columbus County and more particularly described as follows:

> BEGINNING at a new iron pipe in the Southern margin of U.S. Highway No. 74-76, said beginning point being the Northeast corner of Tract No. One of a survey for Columbus County Hospital made by Willis & Walker, Registered Surveyors, dated September 25, 1972, and also being North 83 degrees 47 minutes East 581.73 feet from the Northeast corner of that tract conveyed by J.T. McKenzie to W.E. Miller dated February 23, 1935; and recorded in Deed Book 145, at Page 222, said tract being the site of the existing Columbus County Hospital; and running thence from said point of beginning North 83 degrees 47 minutes East 581.74 feet to a new iron pipe in the Southern margin of U.S. Highway 74-76, said point being 36 feet South of the center-line of said highway; thence a new line South 3 degrees 16 minutes 40 seconds West 749 feet to a new iron pipe; thence a new line South 83 degrees 49 minutes 30 seconds West 584.25 feet to a new iron pipe, the Southeast corner of Tract No. One of a survey for Columbus County Hospital made by Willis & Walker, Registered Surveyors, dated September 25, 1972; thence with the Eastern line of Tract No. One, North 3 degrees 28 minutes 20 seconds East 749 feet to the beginning, containing 9.89 acres, more or less, and being a portion of the lands described in deed dated March 30, 1938, from J.T. McKenzie and wife, Meda McKenzie, to Doris McKenzie, and recorded in Deed Book 154, Page 10, Columbus County Registry, and being known as Tract No. 2 of a survey p by Willis & Walker, Registered Surveyors, dated September 25, 1972; and being subject to additional highway right-of-way as recorded in Deed Book 234, Page 578, Columbus County Registry.

TO HAVE AND TO HOLD the same and the privileges and appurtenances thereunto in any wise appertaining to the Lessee and its successors, upon the following terms and conditions:

1. TERM OF LEASE AND USE OF FUNDS. The term of this lease shall commence upon the execution thereof, and shall continue thereafter until March 6, 1987. All profits, funds, and gifts accumulated by the hospital shall be held by the hospital and used only in the regular operation of the hospital and expansion or replacement of buildings and equipment.

The Lessee shall not erect any new buildings without the consent of the Board of Commissioners of Columbus County.

- 2. RENTAL PAYMENT. The annual rental payment for the term hereof shall be the sum of \$1.00 per year payable on or before the \_\_\_\_ day of \_\_\_\_\_, 19\_\_\_, and on or before the \_\_\_ day of \_\_\_\_\_, of each succeeding year thereafter during the term hereof.
- 3. NAME OF FACILITIES. The hospital facilities on the leased premises shall bear the name of Columbus County Hospital, Inc.
- 4. <u>USE OF PREMISES</u>. The leased premises shall be used for the operation of a non-profit hospital, and such auxiliary activities as Lessee may deem necessary and admissable in connection therewith, subject to the terms and conditions herein contained. Lessee covenants that the hospital facilities shall continue to operate on a non-profit association in accordance with the privisions of the laws of the State of North Carolina during the full term hereof, and that Lessee will continue to operate the hospital facilities known as Columbus County Hospital, Inc., as a non-profit hospital to furnish hospital, clinic or related services to the people of Columbus County, to provide for the care and maintenance of the indigent sick and afflicted poor of Columbus County in substantially the same manner that Lessee is now providing.

## 5. <u>COMPOSITION OF LESSEE</u>.

- (a) The Lessee shall be composed of the seven names whose signatures are affixed at the concluding page of this lease document. If, through death or resignation, a vacancy occurs among the seven members, the remaining six members, the remaining six members shall search and select a successor, providing further that at least one hospital trustee shall reside in each county commissioner's district or zone.
- (b) The Board of Trustees of Columbus County Hospital shall receive no compensation for the performance of their duties as a hospital trustee.

## 6. RESPONSIBILITIES OF LESSEE.

- (a) Shall cause to be prepared and furnish to Lessors an annual audit of the books, records and affairs of Lessee, prepared by an independent Certified Public Accountant mutually satisfactory to Lessors and Lessee. Lessee shall make available to such auditor all necessary books, records and information requested by said auditor for the purpose of obtaining a complete and comprehensive audit. Once each year, at the completion of the hospital audit by the independent auditor, a joint meeting of the Columbus County Commissioners and the Board of Trustees of Columbus County Hospital shall be held at which time the independent auditor will present the audit report to the joint meeting of the financial condition of the hospital and a copy of the audit report will be given to the Chairman of the Columbus County Commissioners.
- (b) Shall operate said hospital facilities in accordance with standard practices for operating hospitals in the State of North Carolina, in compliance with the laws of the State of North Carolina, and rules and regulations of any government body having jurisdiction thereover, and in a manner to fully comply with the duties, responsibilities and obligations of the individual members constituting Trustees of the Columbus County Hospital, Inc., as are fixed by law.

- 7. <u>DUTIES OF LESSEE</u>. Lessee agrees to make no unlawful or offensive use of the premises, to keep the same in good repair, and to deliver up the same at the endo of the term hereof in good order and condition, ordinary wear and tear, fire and other unavoidable accidents excepted.
- 8. <u>COLUMBUS COUNTY NOT RESPONSIBLE FOR OPERATIONS</u>. Lessors shall not be responsible in any wise for any mismanagement or failure to operate said hospital in a proper manner, nor shall Lessors, without its consent, be or become responsible for any financial deficit in the operation of the hospital not previously authorized by the County of Columbus.
- 9. <u>DESTRUCTION OF BUILDING BY FIRE OR CASUALTY</u>. If any of the buildings should be destroyed or rendered unfit for use by fire or other casualty during the term of this Lease, it is understood and agreed that any proceeds derived from insurance as a result of fire or other casualty, together with such proceeds as Columbus County or other parties may see fit to make available, shall be used in the repair or reconstruction of the hospital; and upon the repair or reconstruction of the same, this lease, upon mutual agreement of the parties hereto, shall continue in effect.
- 10. <u>LESSEE TO CARRY INSURANCE</u>. Lessee shall carry such insurance on the property and for its protection in the operation of the hospital and for the protection of Columbus County as their interests may appear, as it deems advisable.

IN WITNESS WHEREOF, Columbus County has caused this instrument to be executed in its corporate name by the Chairman of its Board of County Commissioners and attested by the Secretary of said Board, pursuant to the resolutions duly and regularly adopted at the March 5th, 1973, meeting of said Board of County Commissioners, and also by the individual members comprising the Board of County Commissioners, and the Columbus County Hospital, Inc., has caused this instrument to be executed in its corporate name by its Chairman, and its corporate seal to be affixed thereto and attested by its Secretary, pursuant to resolutions duly and regularly adopted by Trustees of Columbus County Hospital, Inc., at a meeting held Jan. 26, 1973, all as of the day and year first above written.

Ordered: that the Chairman be authorized to execute any and all papers necessary at the ASC Office for transferring allotments from the land purchased from Doris Pridgen for the Hospital.

Ordered: that Jesse Bullard of TAbor City be appointed to serve the unexpired term of J. H. Huffham on the Economic Development Board. Mr. Huffham has moved out of the County.

Ordered: that the Library Board be allowed to pay a salary of \$10,000 per year for a certified librarian. The County will also pay moving expenses up to \$800.00 to help defray expenses of moving into this County if said person will accept employment at the Library.

Ordered: that the Board of Equalization & Review meet each fuesday and Thursday throughout April.

There was a general discussion of the needs of the County as far as additional space is concerned. There was an offer presented to the Board to sell the building known as the "Ward Building" to the County. Upon motion made by Commissioner Buffkin, seconded by Commissioner Brown and unanimously passed as follows:

BE IT RESOLVED that Columbus County purchase the "Ward Building" from Kermit Ward and Wife at a purchase price of \$80,000 upon the condition that the eastern side of the first floor of the building be made available for County use by September 3, 1973, and further provided that the cost of said building and renewations can be made from Revenue Sharing Funds.

- ROAD PETITIONS: 1.Ransom Township Road known as "Currituck, Onslow, & Edgecomb Drive" in Pineland Acres. Road is one mile in length and has 3 occupied homes located on it.
  - 2.Lees Township- This road is 1.9 miles in length and has 11 occupied homes located on it. SR#1158
  - 3.Whiteville Township- This road is known as the George Estates It is  $\frac{1}{2}$  mile in length and has 13 occupied homes located on it.

A group of citizens came from the Hallsboro area, with Bobby Sessions as spokesman, and asked for support of the Board for the athletic programs at the schools in the County. They stated the programs at all schools needed money for uniforms and other equipment.

Upon motion the meeting adjourned until March 19, 1973, at 10:00 a.m.
