NOW, THEREFORE BE IT RESOLVED BY THE BOARD OF COMMISSIONERS for the County of Columbus that.

Section 1. The Board of Commissioners hereby consents to the joining of the Lower Cape Fear Water & Sewer Authority by the County of Brunswick.

WHEREAS, Girlie McGreary heretofore executed a lien to the County of Columbus to secure to the County certain payments to him by the Department of Social Services; and

WHEREAS, the said Girlie McGreary lien heretofore mentioned is recorded in the office of the Clerk of Superior Court of Columbus County in OAA Lien Book 1, page 579; and

WHEREAS, certain property hereinafter described which is now or heretofore has been owned by Girlie McGreary has a fair market value of \$250.00; and

WHEREAS, the County Attorney has negotiated with Frank McGougan, Attorney and Owner, Leatie Lovett and has collected the sum of \$250.00 for the County of Columbus; and

WHEREAS, the said Attorney and Leatie Lovett and the County Attorney have requested that the said property hereinafter described be released from the said AA Lien as recorded in Lien Book I, page 579, upon payment to the County of Columbus, the said sum of \$250.00 which represents the fair market value of said property heretofore owned by Girlie McGreary; and

WHEREAS, the Board of County Commissioners finds as a fact that the foregoing is correct and that the said \$250.00 represents and is a fair market value of the property heretofore, owned by the said Girlie McGreary.

IT IS NOW THEREFORE ORDERED that in consideration of the sum of \$250.00 paid to the County of Columbus, the receipt of which is hereby acknowledged, the said property hereinafter described shall be and is now and forever hereafter released and discharged from OAA Lien as recorded in GAA Lien Book I, page 579, and any and all other Social Services Liens now held by the County of Columbus on said property whether the same is expressly hereinafter referred to or not, it being the expressed intention of the Board of Commissioners that all county liens on all said property with the exception of any county taxes due, shall be discharged from said property. The said property released from the above mentioned county lien or liens is described as follows:

BEGINNING at a stake in J. L. Lewis corner on the south side of the Tabor Road and runs north 86 west 28 chains to a stake in the edge of yard near a house, Richard Turbeville's old corner; thence north 15 east 20 chains to a stake, Mrs. Fannie Turbeville's line; thence south 16 west 20 chains to the beginning, containing 54 acres, more or less, and being a portion of the land as conveyed by the Bank of Fair Bluff to C. R. Turbeville and same as conveyed to C. R. Turbeville and wife, to C. C. Enzor, deed recorded in Book 134, page 298, Records of Columbus County.

Being the same tract or parcel of land as described in that certain deed dated

October 15, 1932, from C. C. Enzor and wife, Lutie B. Enzor, to N. A. Lovett and wife Leatie Lovett, as recorded in Book 140, page 381, Records of Columbus County.

It is expressly directed that the liens are not to be cancelled but that the property hereinabove described be released therefrom and that the office if the Clerk of Superior Court shall be notified of this action so that a notification may be made on the records.
