The Board of Commissioners for the County of Columbus, North Carolina, met in adjourned regular session at the Columbus County Administrative Building in Whiteville, North Carolina, the regular place of meeting, at lo o'clock A.M., on August 30,1976.

Present: Chairman Donald P. Currie, presiding, and Commissioners C. Waldo Marlowe, Edward W. Williamson and Mayo Brown.

Absent: Commissioner Buffkin

Also present: Emogene W. Suggs, County Accountant and ex officio Clerk of the Board of Commissioners.

Commissioner Edward W. Williamson intorduced the following order authorizing bonds which was read:

## ORDER AUTHORIZING \$4,500,000 WATER BONDS

BE IT ORDERED by the Board of Commissioners of the County of Columbus:

- 1. That, pursuant to the Local Government Bond Act, as amended, the County of Columbus, North Carolina, is hereby authorized to contract a debt, in addition to any and all other debts which said County may now or hereafter have power or authority to contract, and in evidence thereof to issue Water Bonds in an aggregate principal amount not exceeding \$4,500,000.00 for the purpose of providing funds, with any other available funds, for the construction of a water system for said County, including supply, storage, treatment, distribution and appurtenant facilities, the acquisition of an existing water line for incorporation into such system and the acquisition of any necessary land, rights-of-way and equipment.
- 2. That taxes shall be levied in an amount sufficient to pay the principal of and the interest on said bonds.
- 3. That a sworn statement of the debt of the County had been filed with the County Accountant and ex officio Clerk of the Board and is open to public inspection.
- 4. That this order shall take effect when approved by the voters of the County at a referendum as provided in said act.

Said Board of Commissioners thereupon designated the County Accountant and ex officio Clerk as the officer whose duty it shall be to make and file with herself as clerk the sworn statement of debt of the County which is required by The Local Government Bond Act, as amended, to be filed after the bond order has been introduced and before the public hearing thereon.

Thereupon the County Accountant and ex officio Clerk filed with her self as clerk, in presence of the Board of Commissioners, the sworn statement of debt as so required.

Thereuopn the order entitled:

ORDER AUTHORIZING \$4,500,000 WATER BONDS was passed on first reading.

On motion duly made, seconded and unanimously carried the Board of Commissioners fixed 8:00 P.M., September 17, 1976, as the hour and day for the public hearing upon the fore-

going order, and directed the County Accountant and ex officio Clerk to publish said order, together with the appended statement as required by the Local Government Bond Act, as amended, once in THE NEWS REPORTER not later than the sixth day before said date.
