The meeting was called to order and the purpose of the meeting was stated by the Chairman of the Planning Board.

A presentation was made by Chap Nobles and John Ingram on the proposed plan for the first phase of the County Wide Water System which would install a large water tank between Whiteville and Chadbourn and a second smaller tank in the Grice area with a 12 inch connecting line. There was general agreement among those present and a motion was made by Commissioner Marlowe, seconded by Commissioner Brown and unanimously passed by those present to accept the plan and proceed with application for a grant under the Public Works Act through the Economic Development Agency to fund this phase of the County Wide Water System. This phase is to be of no cost to the County.

The Commissioners had previously been presented a land use plan for consideration by the Planning Board. They were asked to study the proposed plan and set public hearings in the near future so all citizens of the County may have a chance to be heard.

Upon motion the meeting adjourned until October 4, 1976, at 10:00 a.m.
