The meeting was called to order by the Vice-Chairman and the invocation was given by The Reverend Walkup, Pastor, First Baptist Church, Whiteville.

The minutes of the November 1st meeting were approved as recorded.

A Progress Report on the Columbus County Hospital was presented to the Board Members for review. The percentage of completion at the end of October was 82%.

The monthly report on tax collections for the month ending October 31st was reviewed by the Board. Total collections for the fiscal year through October are \$1,507,744.01.

Allen Price & William Turner, CPA, Moore & Price, presented the annual audit of county funds to the Board. Mr. Price stated that the County was in sound financial condition but not rich. It was recommended to the Board that the use of the computer in the tax departments would cut auditing time about half as the greater part of time worked was in the tax collecting office in reconciling taxes. He also stated that Columbus County was below the average in the percentage of collections and recommended that stronger methods of collection be used. He invited questions by the Board now or at a later time. A contract for the present fiscal year to employ Moore & Price to do the annual audit was considered by the Board at this time. A motion was made by Commissioner Marlowe, seconded by Commissioner Williamson, and unanimously carried to execute the contract to employ Moore & Price at a rate of \$90.00 per accountant per day.

A letter of recommendation from Dottie Crouch to name members for a Council on the Status of Women for Columbus County was presented to the Board for consideration. A motion was made by Commissioner Williamson, seconded by Commissioner Marlowe and duly passed to name the following persons to the Council:

Ordered: that the 1976 taxes listed in the name of Raybon & Frances F. Jenkins, Waccamaw Township, be released on the valuation of \$6,400 as house was only 50% complete on January 1, 1976.
